






Figure 2. Excellent Signal Integrity





Figure 3. Load Circuit and Voltage Waveforms


LOAD CIRCUIT

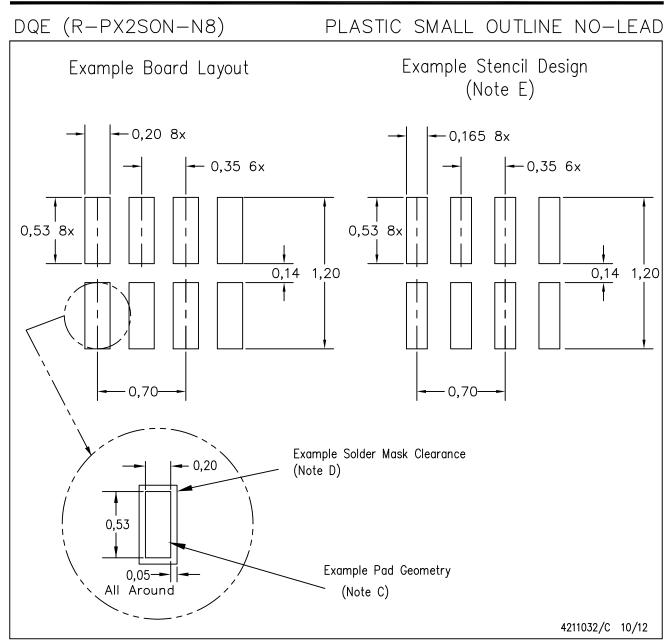

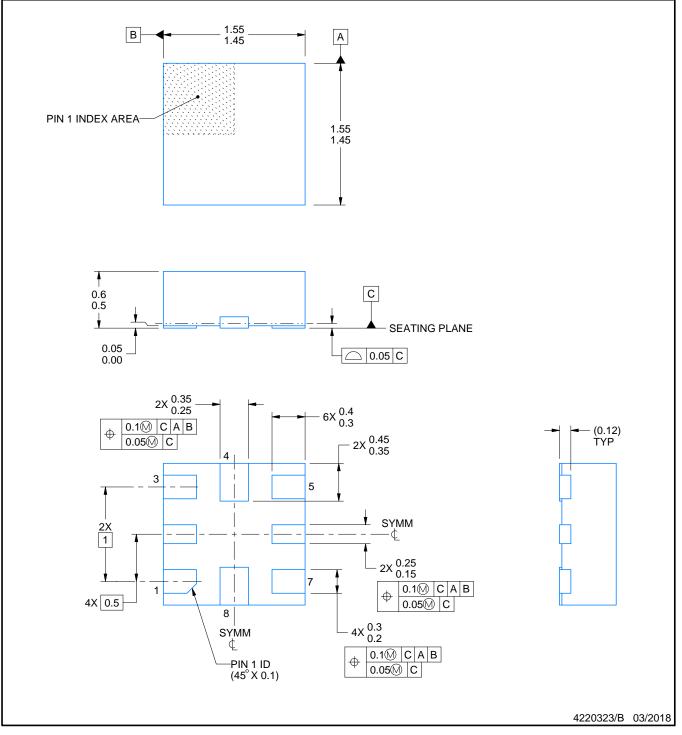

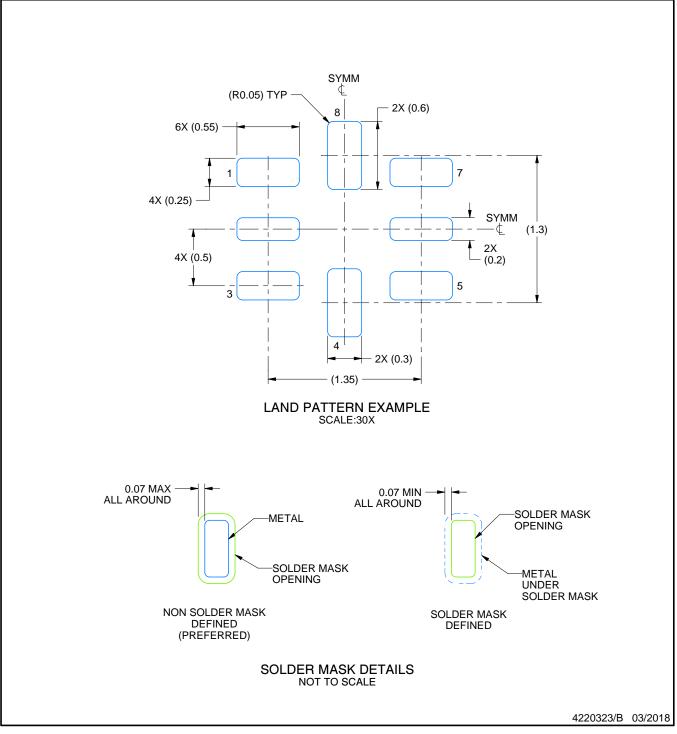

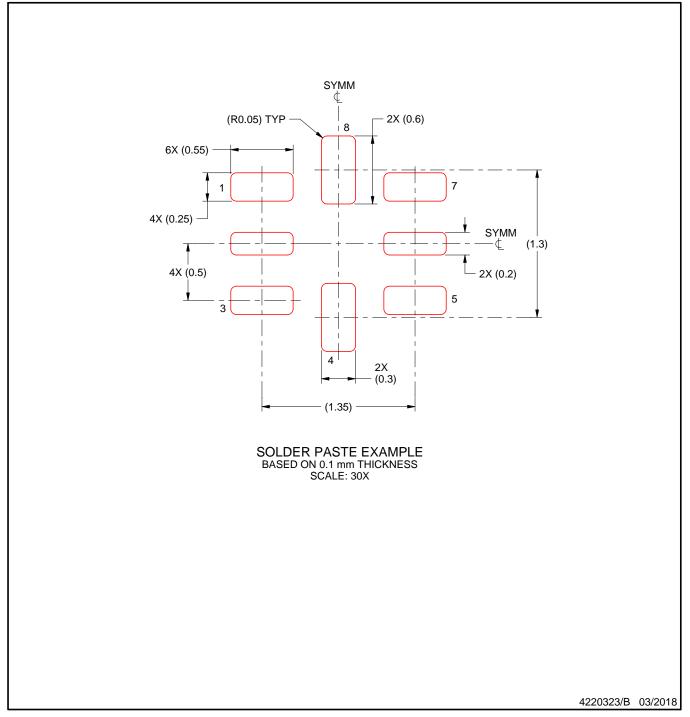

PLASTIC QUAD FLATPACK - NO LEAD




