The SN74LVC1G123 device is a single retriggerable monostable multivibrator designed for 1.65-V to 5.5-V V<sub>CC</sub> operation.

This monostable multivibrator features output pulseduration control by three methods. In the first method, the A input is low, and the B input goes high. In the second method, the B input is high, and the  $\overline{A}$  input goes low. In the third method, the A input is low, the B input is high, and the clear ( $\overline{CLR}$ ) input goes high.

The output pulse duration is programmed by selecting external resistance and capacitance values. The external timing capacitor must be connected between Cext and Rext/Cext (positive) and an external resistor connected between Rext/Cext and VCC. To obtain variable pulse durations, connect an external variable resistance between Rext/Cext and VCC. The output pulse duration also can be reduced by taking CLR low.


Pulse triggering occurs at a particular voltage level and is not directly related to the transition time of the input pulse. The A and B inputs have Schmitt triggers with sufficient hysteresis to handle slow input transition rates with jitter-free triggering at the outputs.







## Figure 1. Required Timing Circuit




Figure 2. Input/Output Timing Diagram





## 8 Detailed Description

The SN74LVC1G123 device is a single retriggerable monostable multivibrator designed for 1.65-V to 5.5-V  $V_{CC}$  operation.

This monostable multivibrator features output pulse-duration control by three methods. In the first method, the  $\overline{A}$  input is low, and the <u>B</u> input goes high. In the second method, the <u>B</u> input is high, and the  $\overline{A}$  input goes low. In the third method, the <u>A</u> input is low, the <u>B</u> input is high, and the clear (CLR) input goes high.

The output pulse duration is programmed by selecting external resistance and capacitance values. The external timing capacitor must be connected between  $C_{ext}$  and  $R_{ext}/C_{ext}$  (positive) and an external resistor connected between  $R_{ext}/C_{ext}$  and  $V_{CC}$ . To obtain variable pulse durations, connect an <u>external</u> variable resistance between  $R_{ext}/C_{ext}$  and  $V_{CC}$ . The output pulse duration also can be reduced by taking CLR low.


Pulse triggering occurs at a particular voltage level and is not directly related to the transition time of the input pulse. The A and B inputs have Schmitt triggers with sufficient hysteresis to handle slow input transition rates with jitter-free triggering at the outputs.

Once triggered, the basic pulse duration can be extended by retriggering the gated low-level-active ( $\overline{A}$ ) or highlevel-active (B) input. Pulse duration can be reduced by taking CLR low. CLR can be used to override  $\overline{A}$  or B inputs. The input/output timing diagram illustrates pulse control by retriggering the inputs and early clearing.

The SN74LVC1G123 device is fully specified for partial-power-down applications using I<sub>off</sub>. The I<sub>off</sub> circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.

NanoFree<sup>™</sup> package technology is a major breakthrough in IC packaging concepts, using the die as the package.

## 8.3 Feature Description

This part is available in the Texas Instruments NanoFree<sup>™</sup> package. It supports 5-V V<sub>CC</sub> operation and accepts inputs up to 5.5 V. The max t<sub>pd</sub> is 8 ns at 3.3 V. It supports mixed-mode voltage operation on all ports.

Down translation can be achieved to  $V_{CC}$  from up to 5.5 V.

Schmitt-trigger circuitry on  $\overline{A}$  and B inputs allows for slow input transition rates. The device can be edge triggered from active-high or active-low gated logic inputs. It can support up to 100% duty cycle from retriggering.

Clear can be used to terminate the output pulse early.

Glitch-free power-up reset is on all outputs.

l<sub>off</sub> supports live insertion, partial-power-down mode, and back-drive protection.

Latch-up performance exceeds 100 mA per JESD 78, Class II.

## 9 Application and Implementation

## 9.1 Application Information

The SN74LVC1G123 can be used for many applications. The application shown here is a switch debounce circuit. Many switches produce multiple triggers when pressed, and the debounce circuit turns the many triggers into one. This circuit takes advantage of the retrigger capability of the SN74LVC1G123 in that the output pulse length only has to be longer than the longest individual bounce (typically less than 1 ms).




Figure 10. Typical Application of the SN74LVC1G123

## 9.2.1 Design Requirements

- 1. Recommended Input Conditions:
  - For specified high and low levels, see V<sub>IH</sub> and V<sub>IL</sub> in *Recommended Operating Conditions*.
  - Inputs and outputs are overvoltage tolerant, allowing them to go as high as 4.6 V at any valid V<sub>CC</sub>.
- 2. Recommended Output Conditions:
  - Load current should not exceed values listed in *Recommended Operating Conditions*.

## 9.2.2 Detailed Design Procedure

The values for V<sub>CC</sub>, R<sub>PU</sub>, R, and C must be selected for proper operation.

 $V_{CC}$  is selected at 1.8 V. This value is usually driven by the logic voltage of the system, but is arbitrary in this case.

 $R_{PU}$  is selected at 10 k $\Omega$ .

R and C are selected via the plots in *Application Curves* and are based on the time desired for the output pulse. In this case, the output pulse will be 1 ms. Since the supply voltage has been selected at 1.8 V, Figure 11 is used to determine the R and C values required. First convert the desired pulse width ( $t_w$ ), 1 ms, to ns. This yields  $10^6$  ns. Next follow that line across to see which R and C values intersect it.

R is selected at 10 k $\Omega$  because that line intersects nicely with 10<sup>6</sup> ns and 10<sup>5</sup> pF, making the selection of C at 0.1  $\mu$ F easy.



In addition to the shown components, a 0.1- $\mu$ F decoupling capacitor from V<sub>CC</sub> to ground should be placed as close as possible to the device.

## 9.2.3 Application Curves





## **10** Power Supply Recommendations

The power supply can be any voltage between the minimum and maximum supply voltage rating listed in the *Recommended Operating Conditions*.

Each V<sub>CC</sub> terminal should have a good bypass capacitor to prevent power disturbance. For devices with a single supply, a 0.1- $\mu$ F bypass capacitor is recommended. If multiple pins are labeled V<sub>CC</sub>, then a 0.01- $\mu$ F or 0.022- $\mu$ F capacitor is recommended for each V<sub>CC</sub> because the V<sub>CC</sub> pins are tied together internally. For devices with dual-supply pins operating at different voltages, for example V<sub>CC</sub> and V<sub>DD</sub>, a 0.1- $\mu$ F bypass capacitor is recommended for each supply pins. To reject different frequencies of noise, use multiple bypass capacitors in parallel. Capacitors with values of 0.1  $\mu$ F and 1  $\mu$ F are commonly used in parallel. The bypass capacitor should be installed as close to the power terminal as possible for best results.

## 11 Layout

## 11.1 Layout Guidelines




Figure 16. Trace Example

Reflections and matching are closely related to the loop antenna theory but are different enough to be discussed separately from the theory. When a PCB trace turns a corner at a 90° angle, a reflection can occur. A reflection occurs primarily because of the change of width of the trace. At the apex of the turn, the trace width increases to 1.414 times the width. This increase upsets the transmission-line characteristics, especially the distributed capacitance and self–inductance of the trace which results in the reflection. Not all PCB traces can be straight and therefore some traces must turn corners. Figure 16 shows progressively better techniques of rounding corners. Only the last example (BEST) maintains constant trace width and minimizes reflections.
