



INPUT VOLTAGE : VI(on) [V]




Fig.2 Output current vs. input voltage (OFF characteristics)




Fig.3 Output current vs. output voltage






Fig.4 DC current gain vs. output current



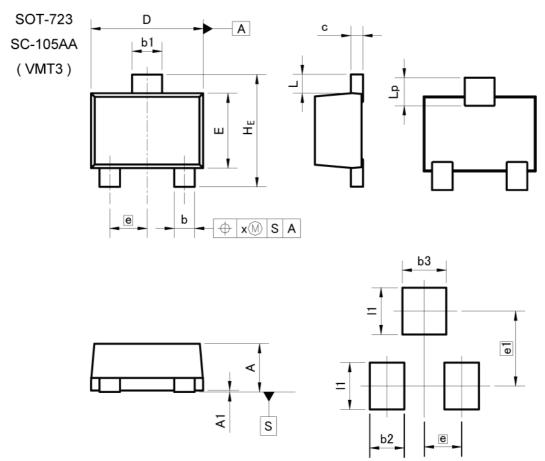



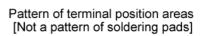
