



Fig.1 Power Dissipation Derating Curve




Fig.2 Drain Current Derating Curve




Fig.3 Typical Output Characteristics(I)





Fig.4 Typical Output Characteristics(II)

Fig.5 Typical Transfer Characteristics





Fig.6 Gate Threshold Voltage vs.

Fig.7 Static Drain - Source On - State Resistance vs. Gate Source Voltage




Fig.8 Static Drain - Source On - State Resistance vs. Junction Temperature





Fig.9 Static Drain - Source On - State Resistance vs. Drain Current (I)

Fig.10 Static Drain - Source On - State Resistance vs. Drain Current (II)




Fig.11 Static Drain - Source On - State Resistance vs. Drain Current (III)





Fig.12 Static Drain - Source On - State Resistance vs. Drain Current (IV)

Drain - Source Voltage




Fig.14 Switching Characteristics





Fig.15 Source Current vs.




