

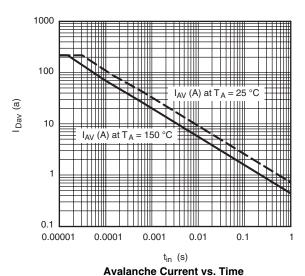




On-Resistance vs. Junction Temperature



T<sub>J</sub> = 150 °C T<sub>J</sub> = 25 °C T<sub>J</sub>


Source-Drain Diode Forward Voltage





T<sub>J</sub> - Drain-Source Breakdown vs. Junction-Temperature




Normalized Thermal Transient Impedance, Junction-to-Case




