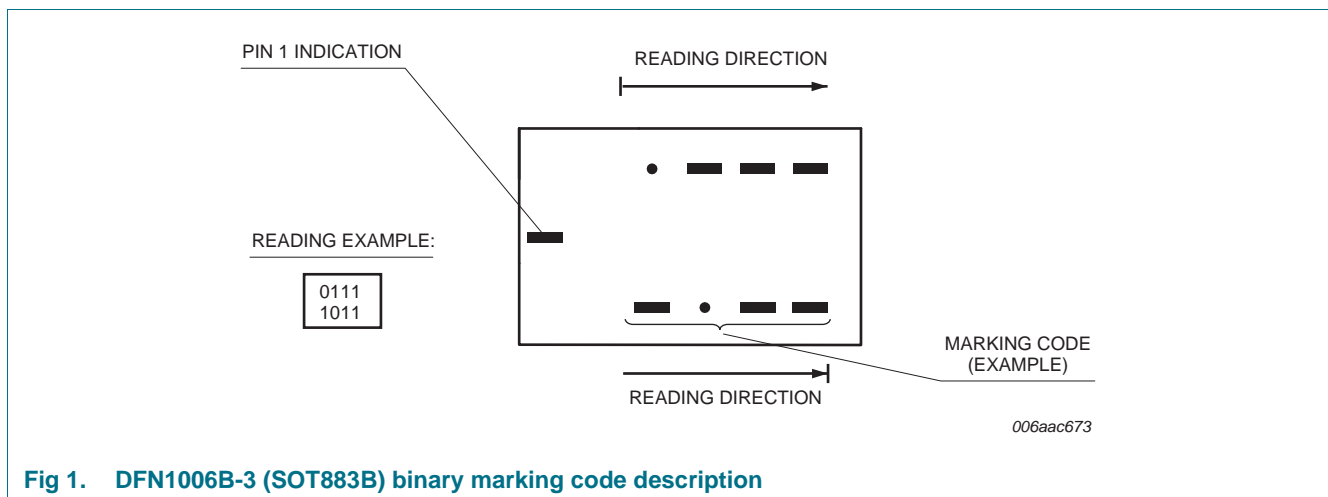

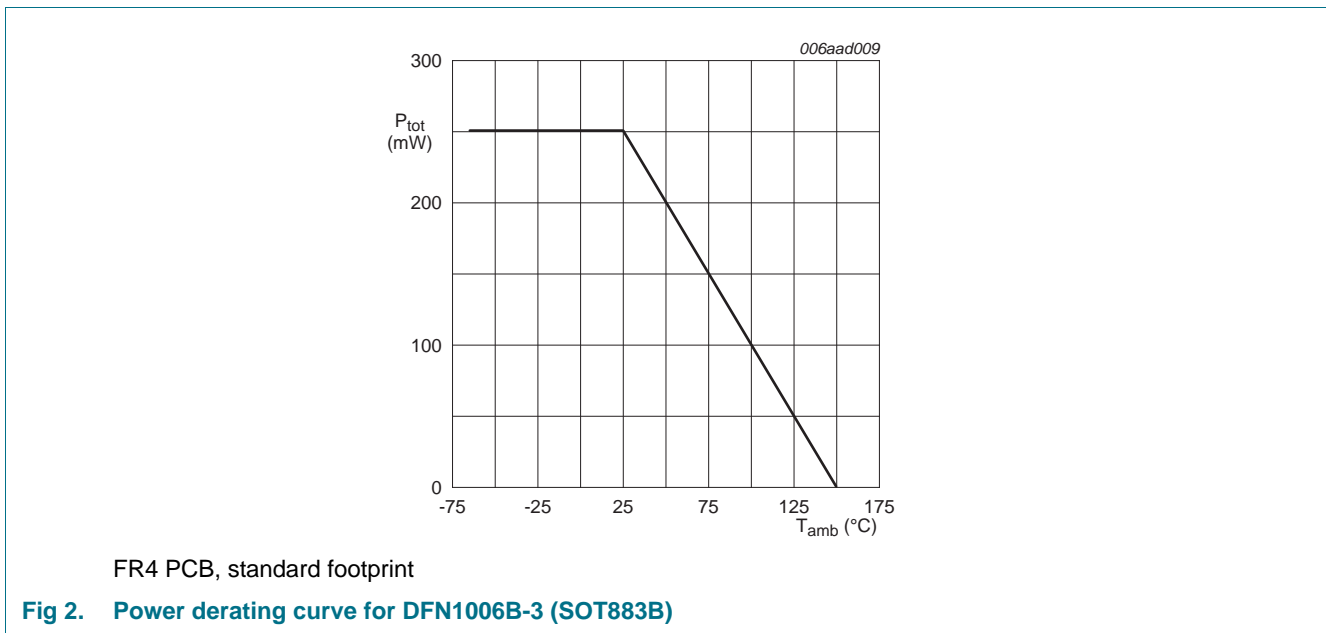

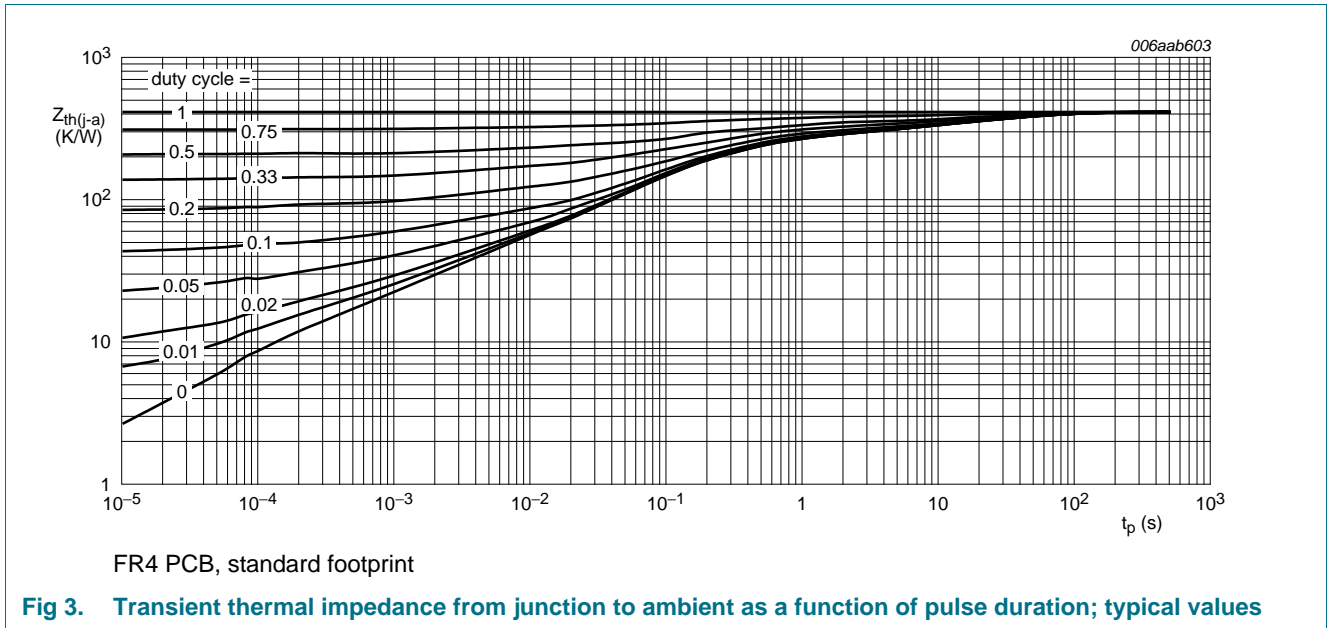

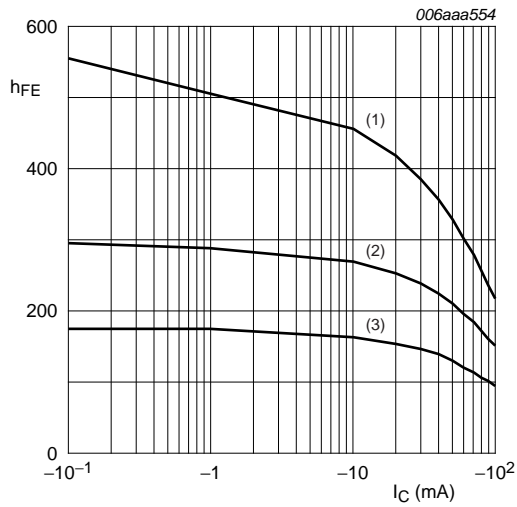

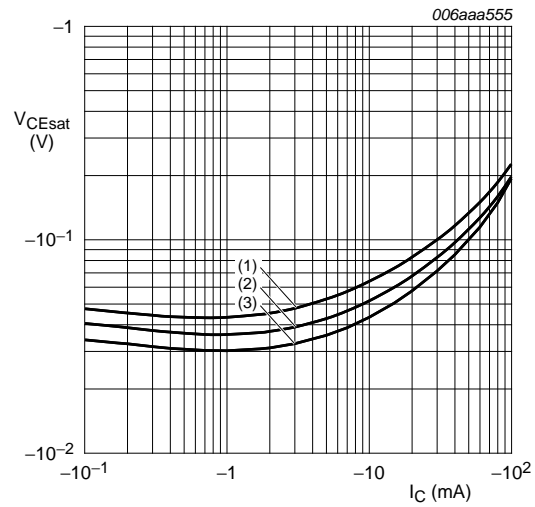

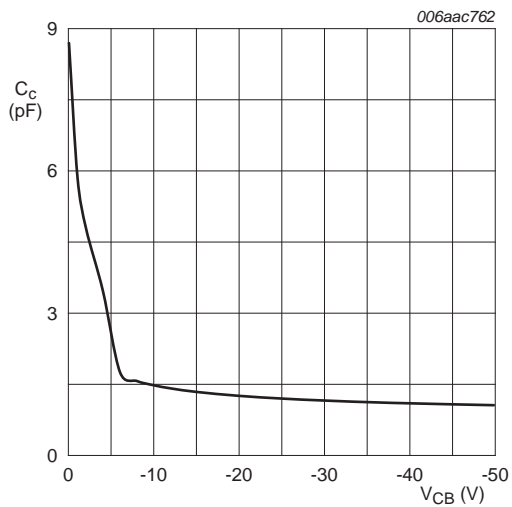

Fig 4. DC current gain as a function of collector current; typical values



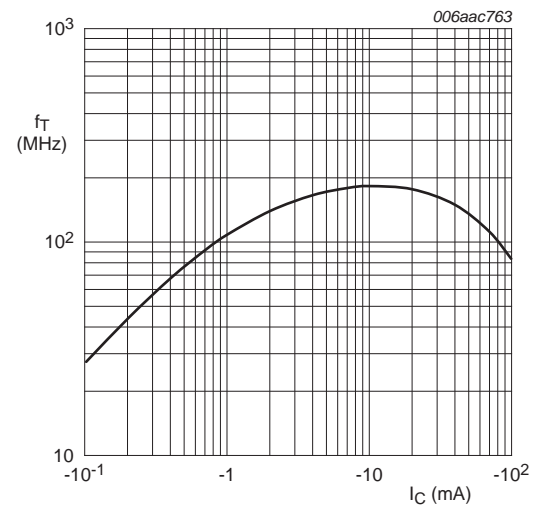

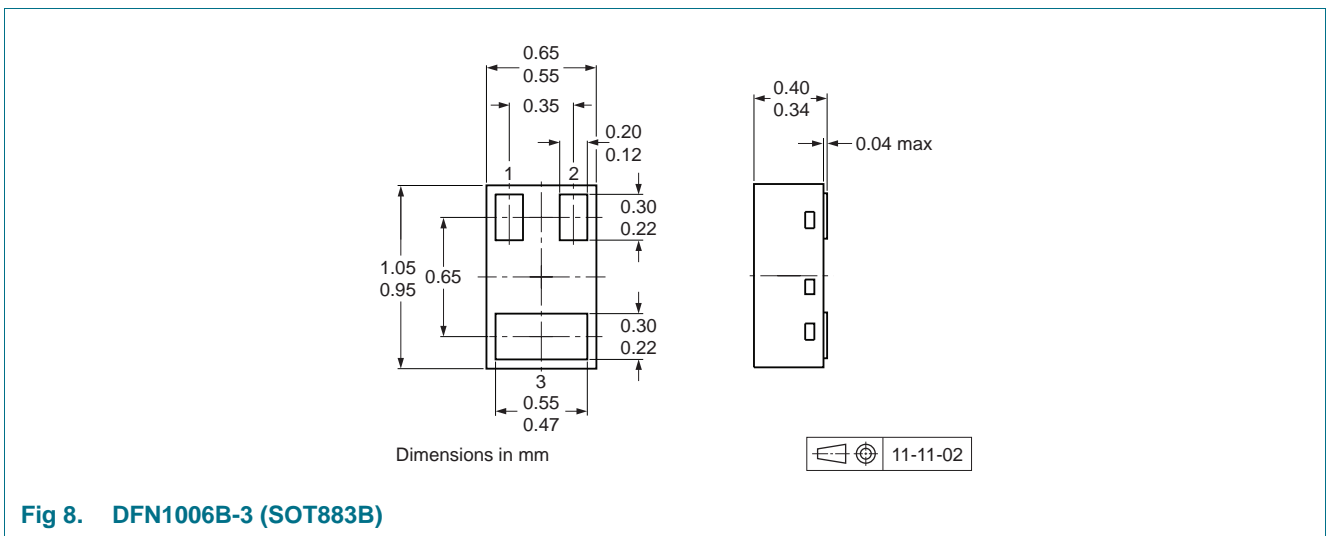
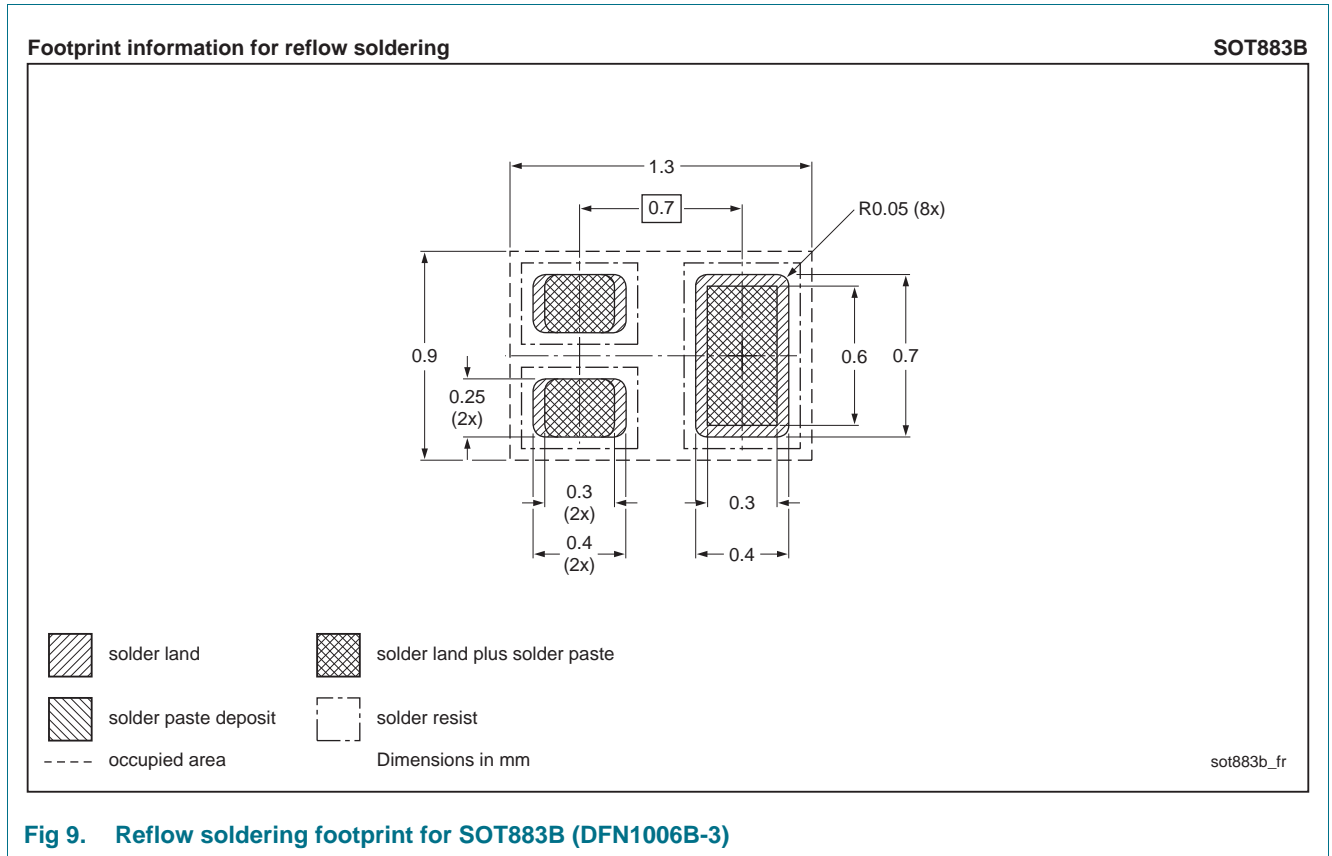


Fig 8. DFN1006B-3 (SOT883B)
