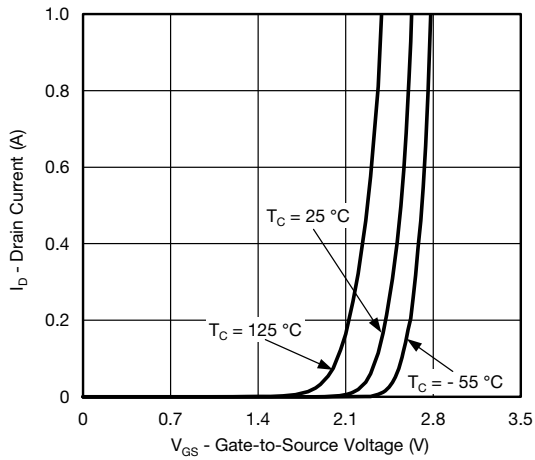

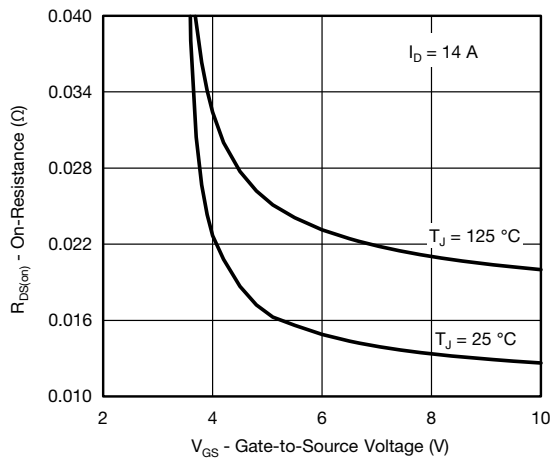

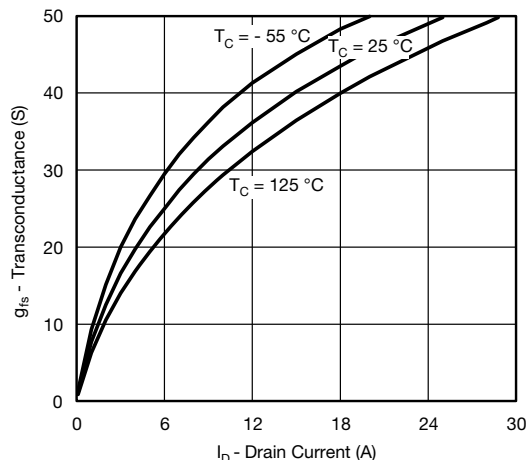
On-Resistance vs. Drain Current



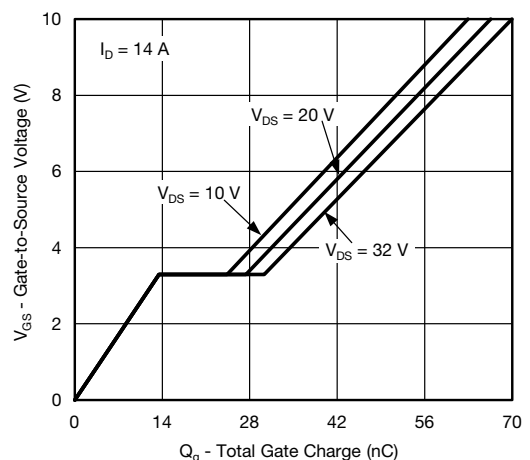
Transfer Characteristics



On-Resistance vs. Gate-to-Source Voltage

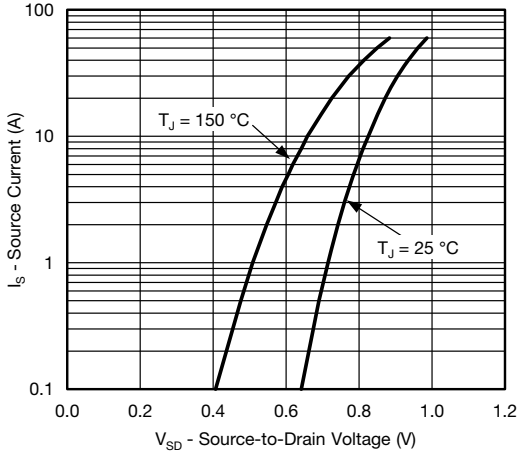

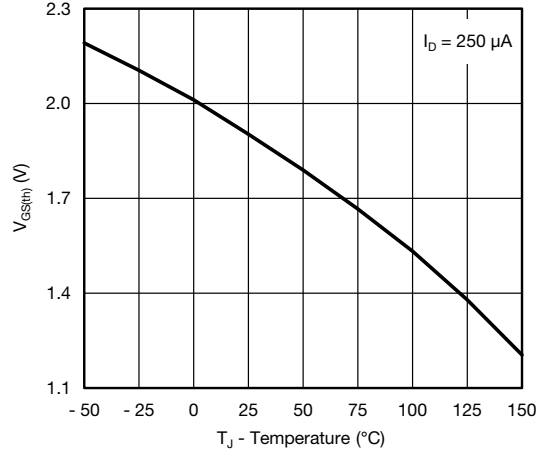

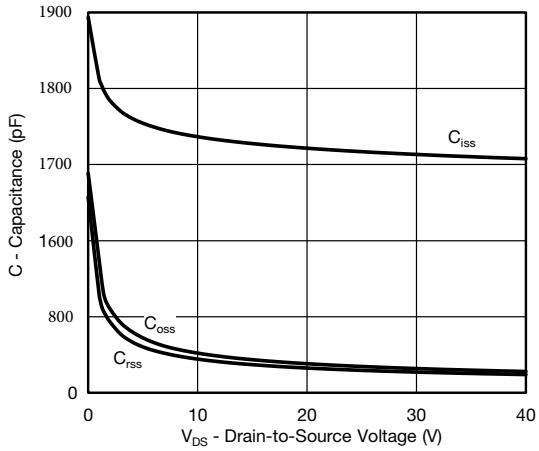

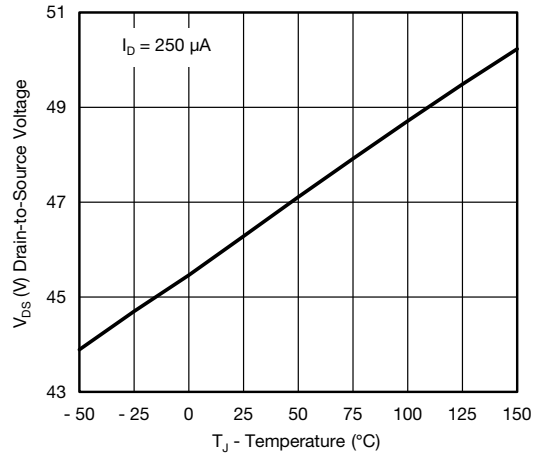
Source-Drain Diode Forward Voltage



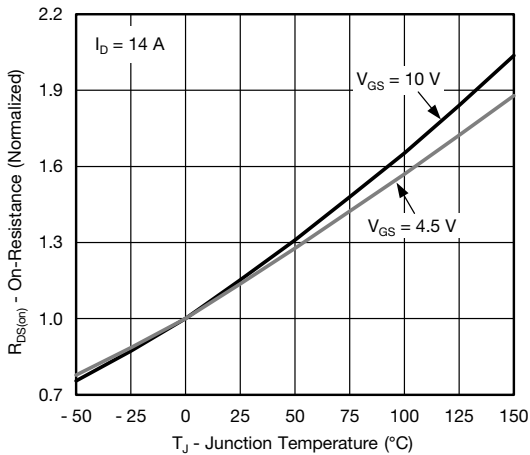

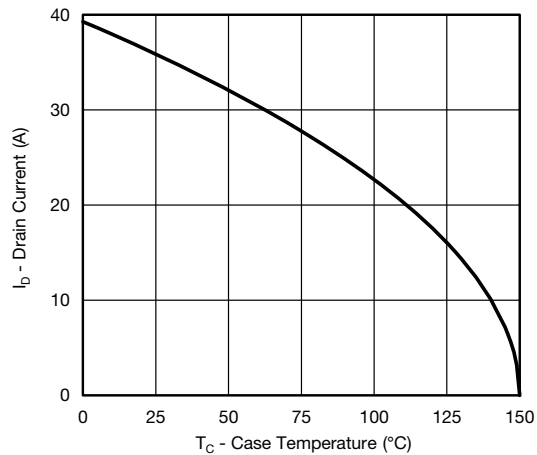

Drain Source Breakdown vs. Junction Temperature

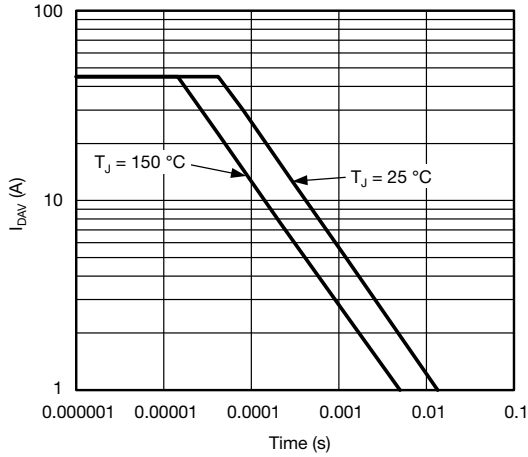

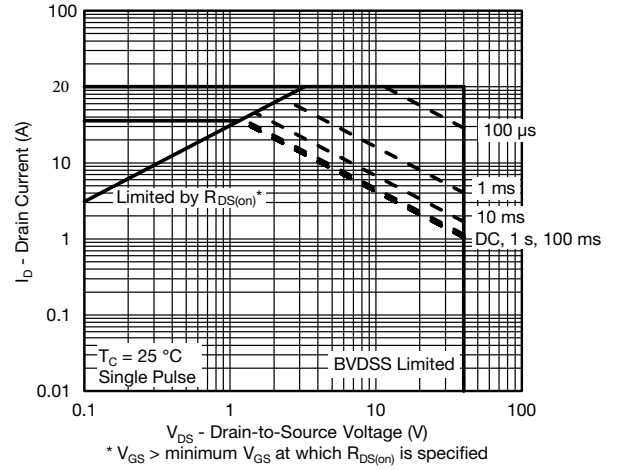

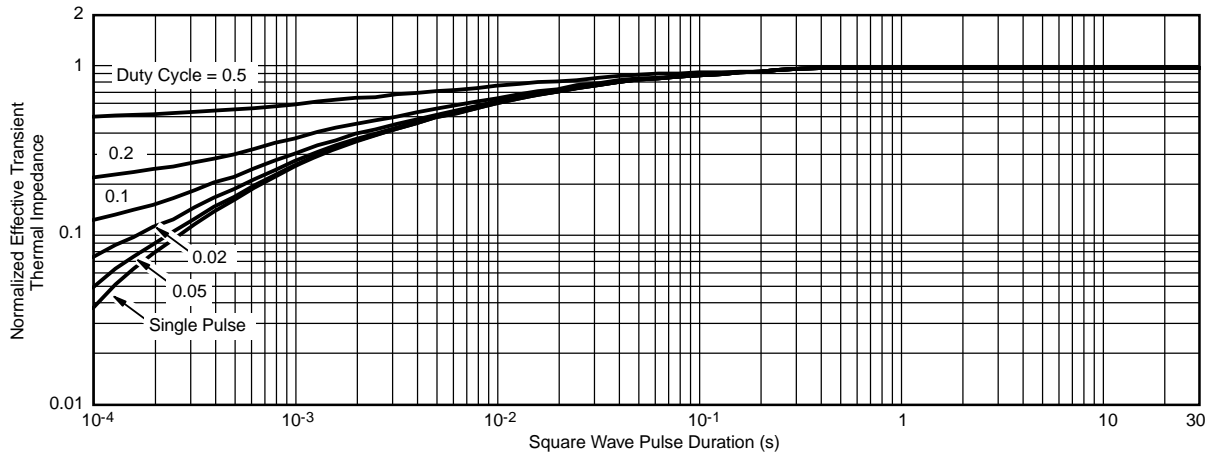
