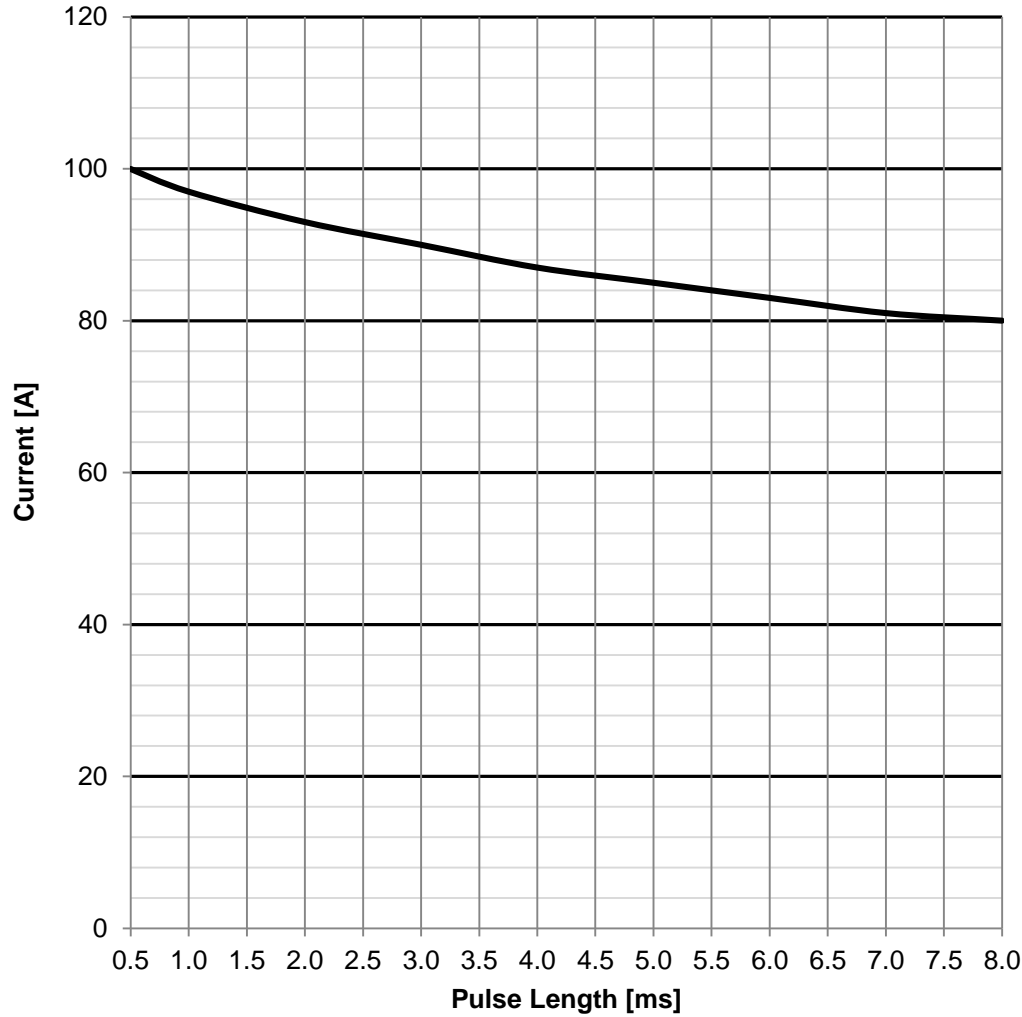

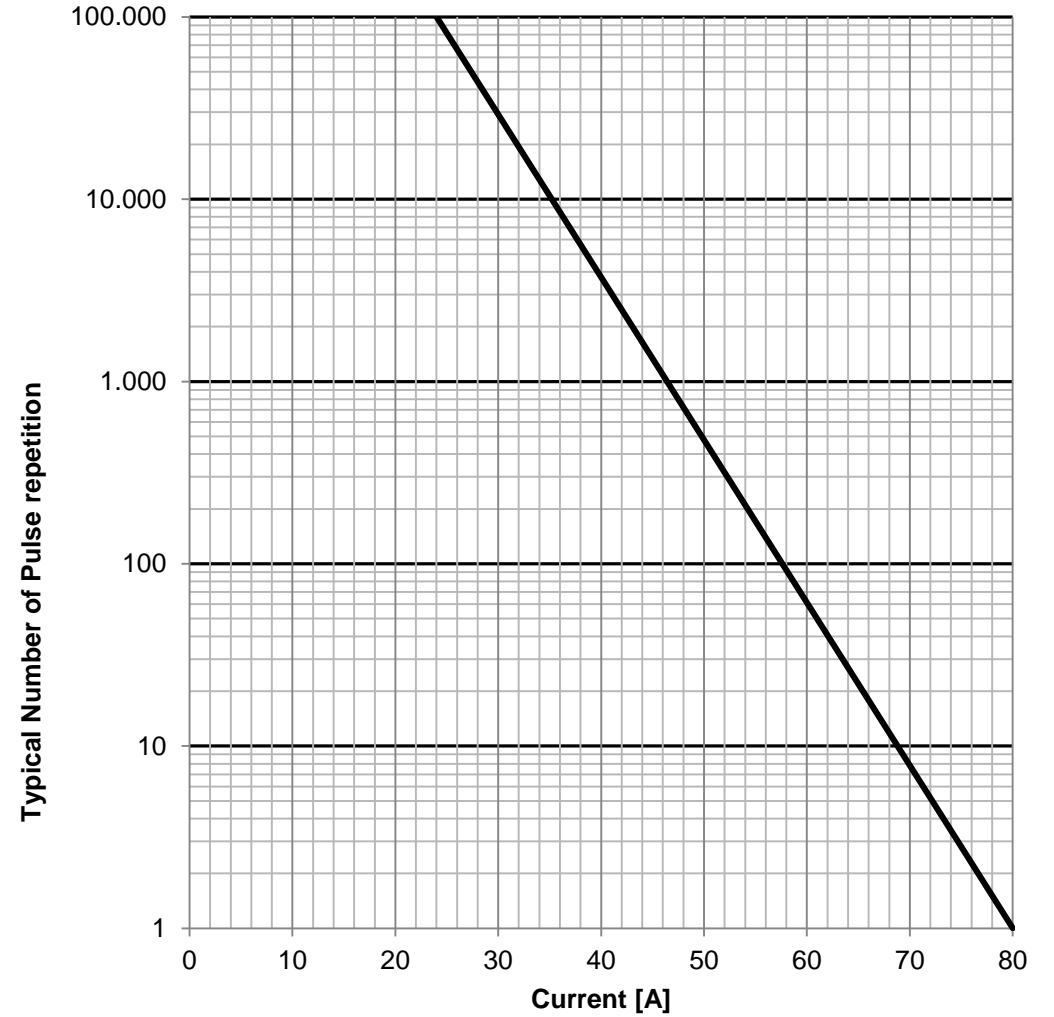

### Typical Number of Pulse Repetition:



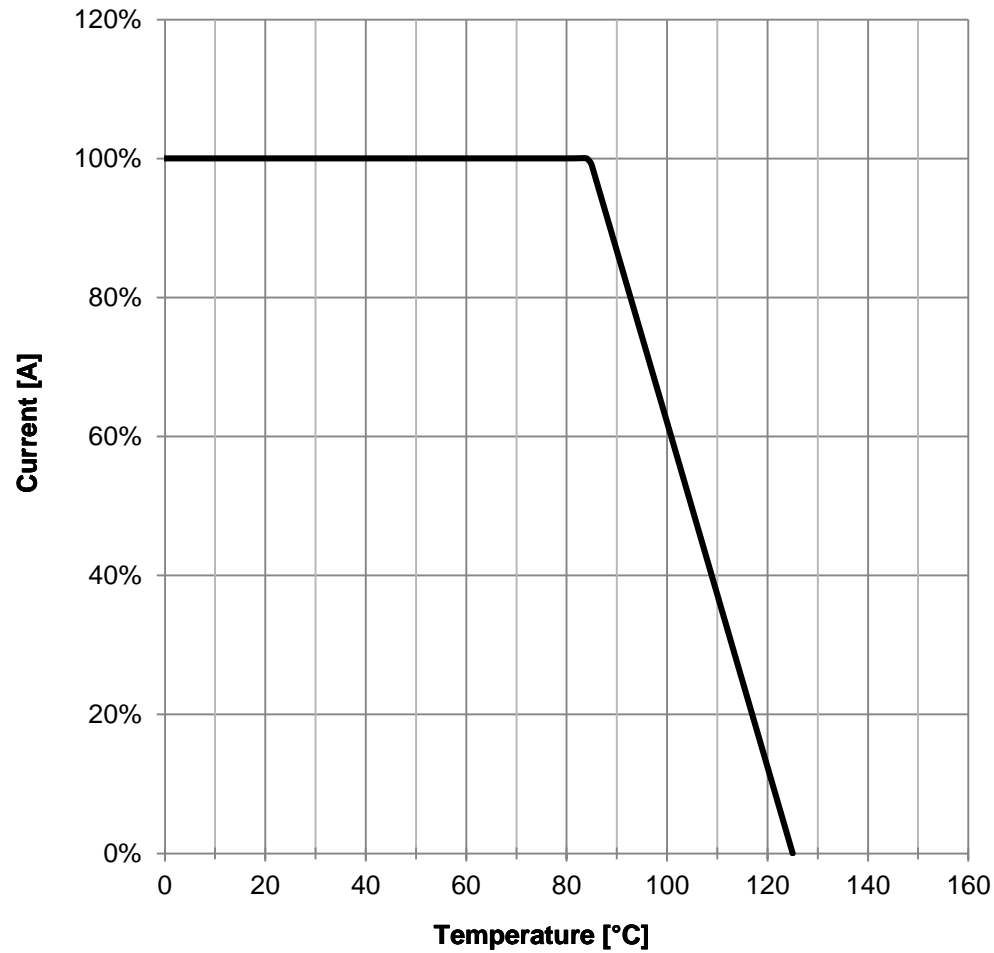



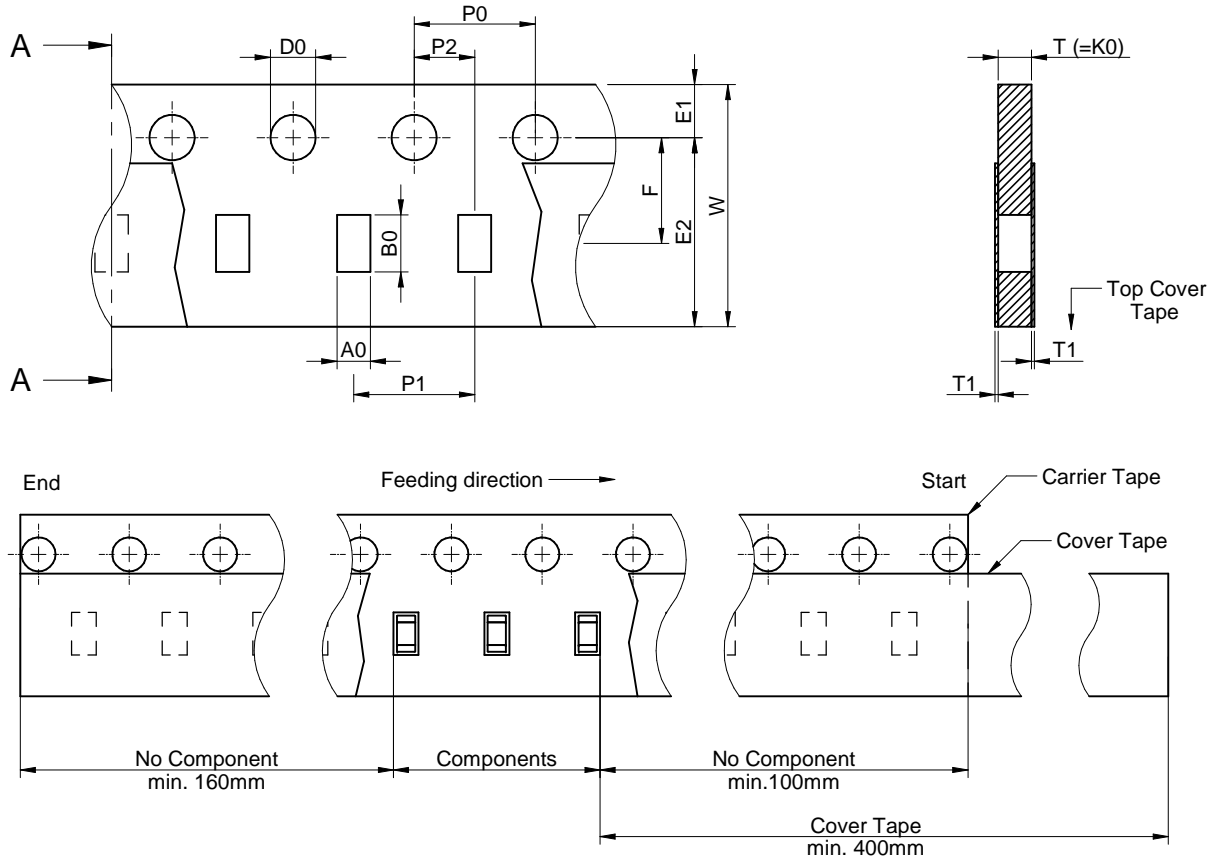
## Derating Curve:

#### Soldering:



## Storage Conditions:


