1. Functional Description

Low-Voltage, Low-Capacitance Dual Bus Switch

2. General

The TC7WBL3305CFK and TC7WBL3306CFK are Low Voltage/Low Capacitance CMOS 2bit Bus Switches. The low ON-resistance of the switch allows connections to be made with minimal propagation delay time. The TC7WBL33306CFK requires the output enable (\overline{OE}) input to be set high to place the output into the high impedance state, whereas the TC7WBL3305CFK requires the output enable (OE) input to be set low to place the output into the high impedance.

All inputs are equipped with protection circuits against static discharge.








7. Block Diagram





12. Rise and Fall Time (tr/tf)

The $t_{r(out)}$ and $t_{f(out)}$ values of the output signals are affected by the CR time constant of the input, which consists of the switch terminal capacitance ($C_{I/O}$) and the on-resistance (R_{ON}) of the input.

In practice, the $t_{r(out)}$ and $t_{f(out)}$ values are also affected by the circuit's capacitance and resistance components other than those of the TC7WBL3305CFK, TC7WBL3306CFK.

The $t_{r(out)}/t_{f(out)}$ values can be approximated as follows. (Figure 12.1, Table 12.1 shows the test circuit.)


 $t_{r(out)}/t_{f(out)} (approx) = -(C_{I/O} + C_L) + (R_{DRIVE} + R_{ON}) + \ln(((V_{OH} - V_{OL}) - V_M) / (V_{OH} - V_{OL}))$ Where, R_{DRIVE} is the output impedance of the previous-stage circuit.






