




#### SHAPES AND DIMENSIONS






#### □INSERTION LOSS

#### □RETURN LOSS

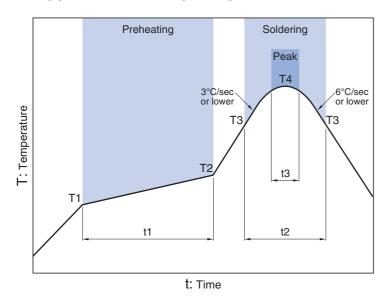
