



Fig 1. Average forward current as a function of ambient temperature; derating curve




(1) $T_{amb} = 85 \, ^{\circ}C$

Fig 3. Reverse current as a function of reverse voltage; typical values




(1) $T_{amb} = 125 \, ^{\circ}C$

Fig 2. Forward current as a function of forward voltage; typical values




 $f = 1 \text{ MHz}; T_{amb} = 25 \text{ }^{\circ}\text{C}$


