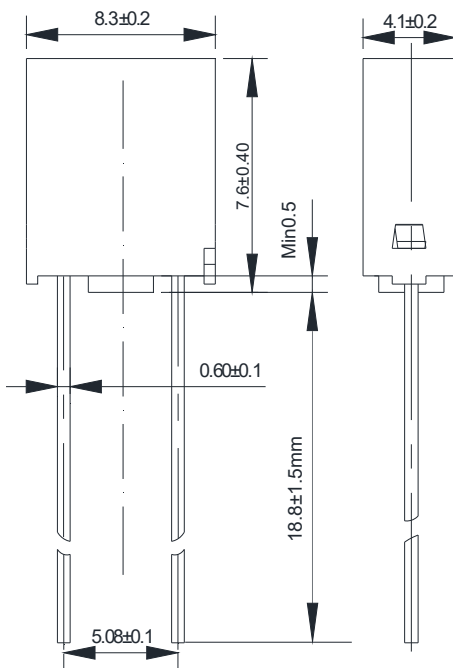

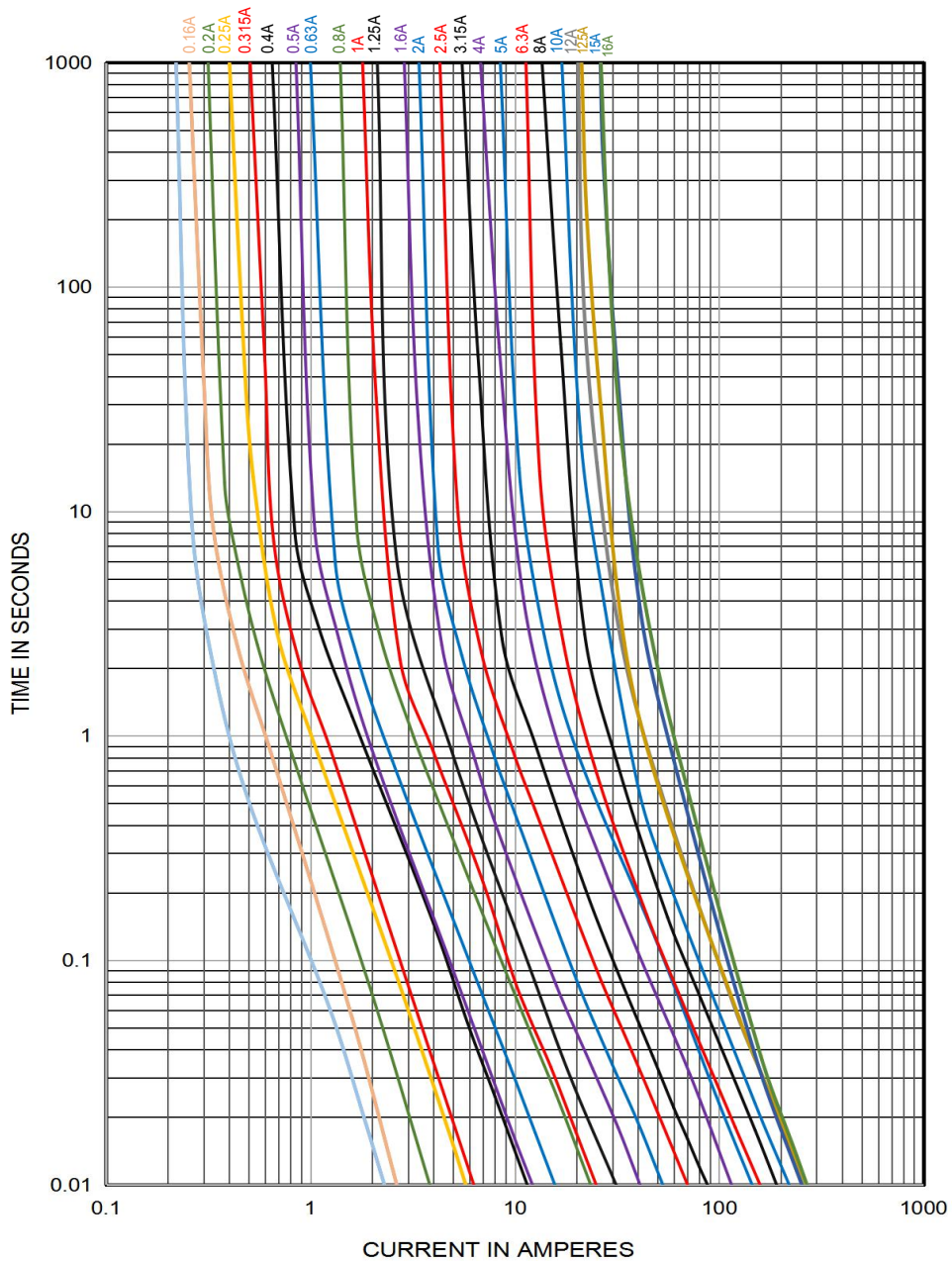

Average Current Curve(I-T Curve)



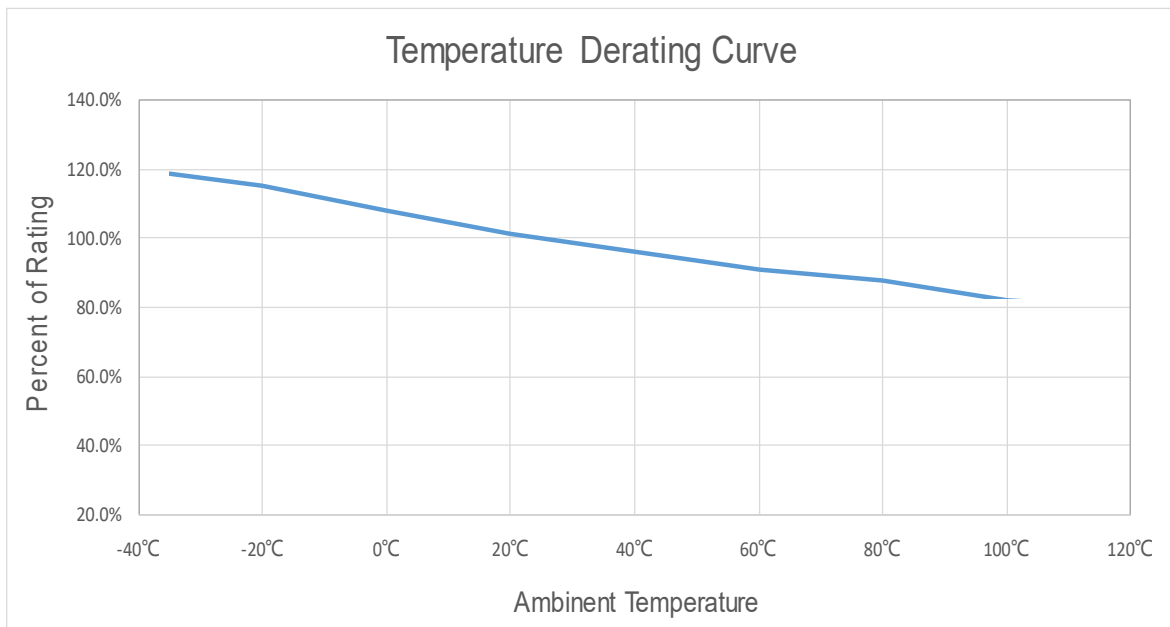

$$\text{Calculation for ideal fuse selection} = \frac{\text{Operating Current (A)}}{\text{Rating (\%} \times 0.75)}$$



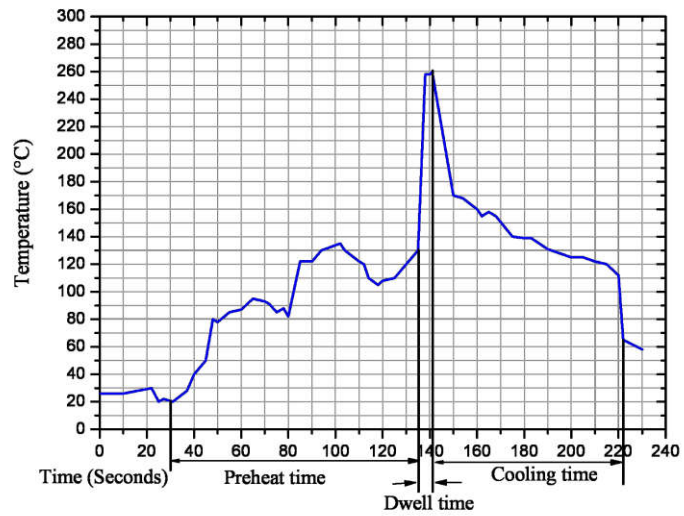
