






Fig. 2 - Relative Luminous Intensity vs. Angular Displacement




Fig. 3 - Relative Intensity vs. Wavelength




Fig. 4 - Forward Current vs. Forward Voltage




Fig. 5 - Relative Luminous Intensity vs. Forward Current







Fig. 6 - Relative Luminous Intensity vs. Ambient Temperature

## **REEL DIMENSIONS** in millimeters




Fig. 7 - Reel Dimensions




Fig. 8 - Tape Direction





Fig. 9 - LED in Tape
