






TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted






Transfer Characteristics

Source-Drain Diode Forward Voltage




On-Resistance vs. Gate-to-Source Voltage






Square Wave Pulse Duration (s) Normalized Thermal Transient Impedance, Junction-to-Foot 10
