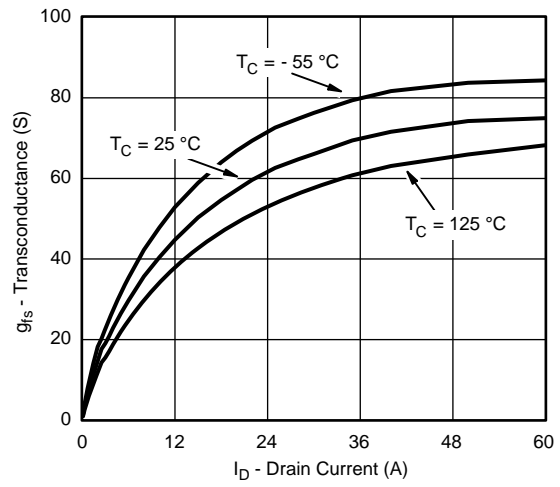

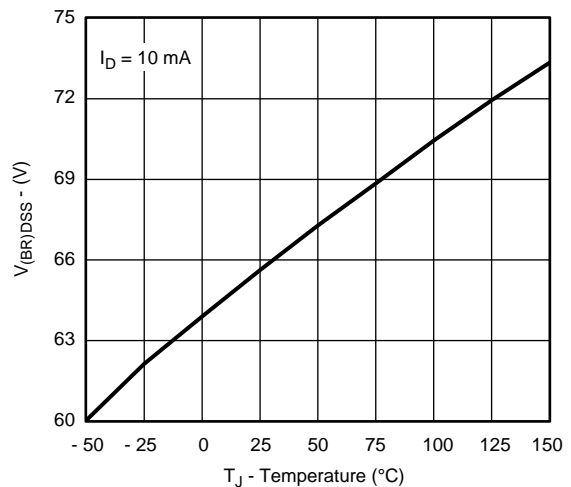
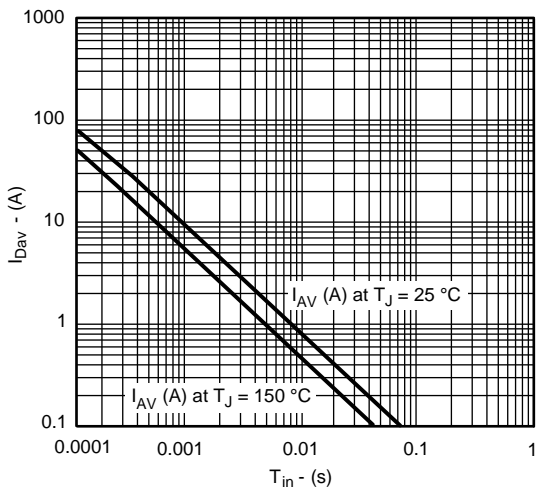
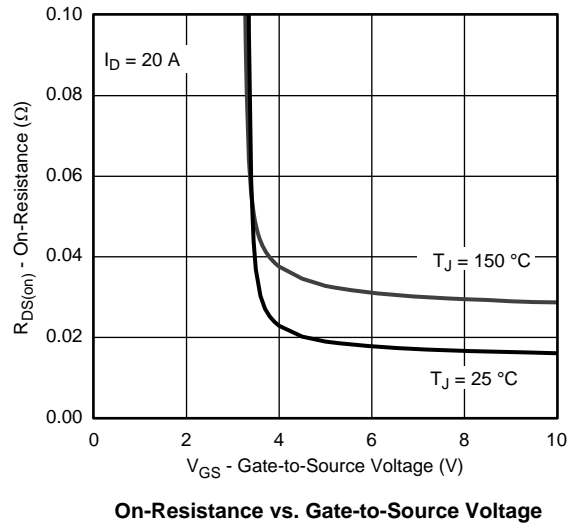
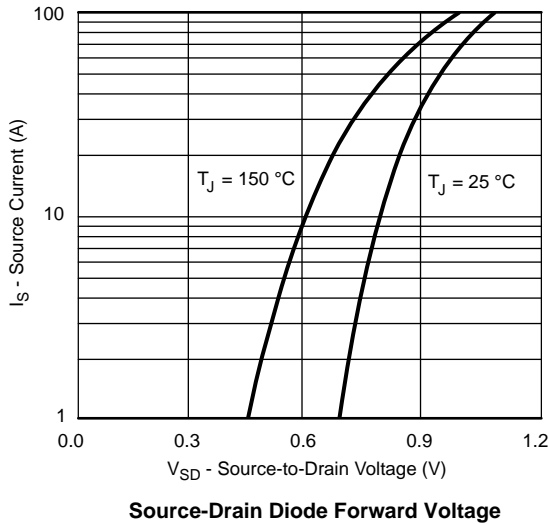
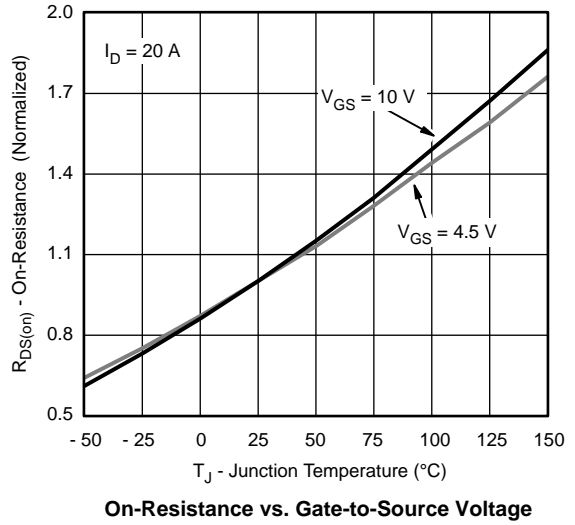
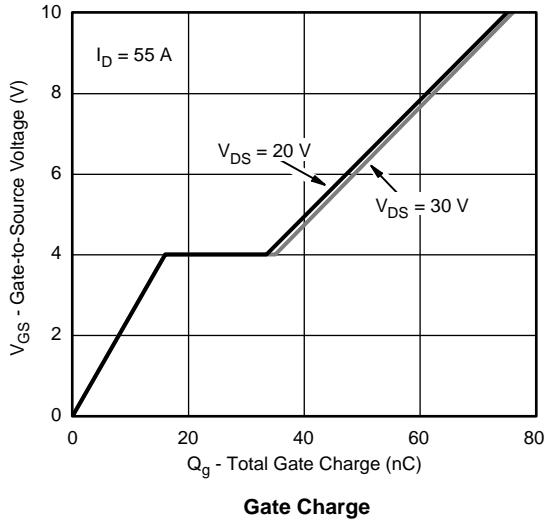


**On-Resistance vs. Drain Current**

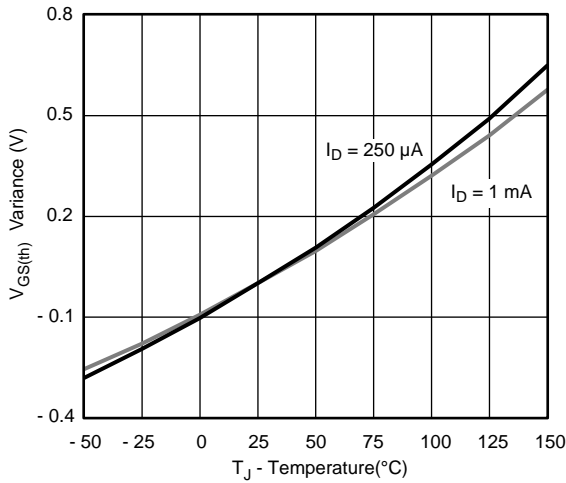

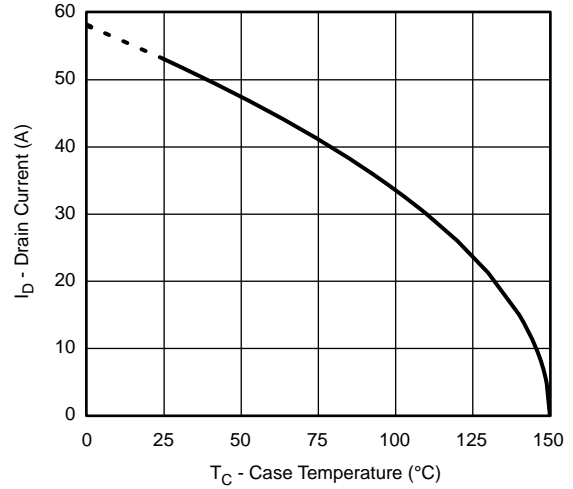

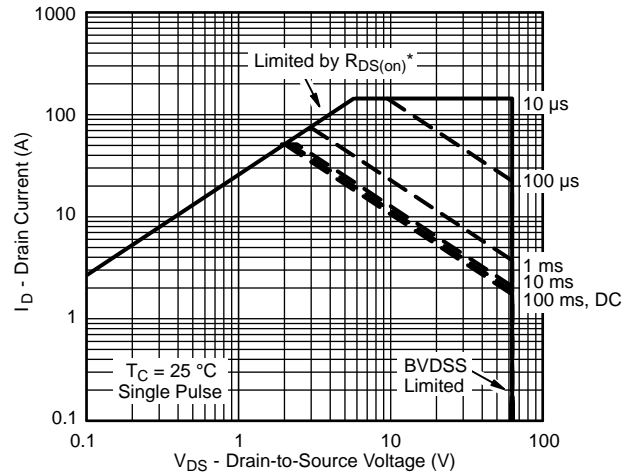
**Threshold Voltage**

**Power Derating, Junction-to-Case**

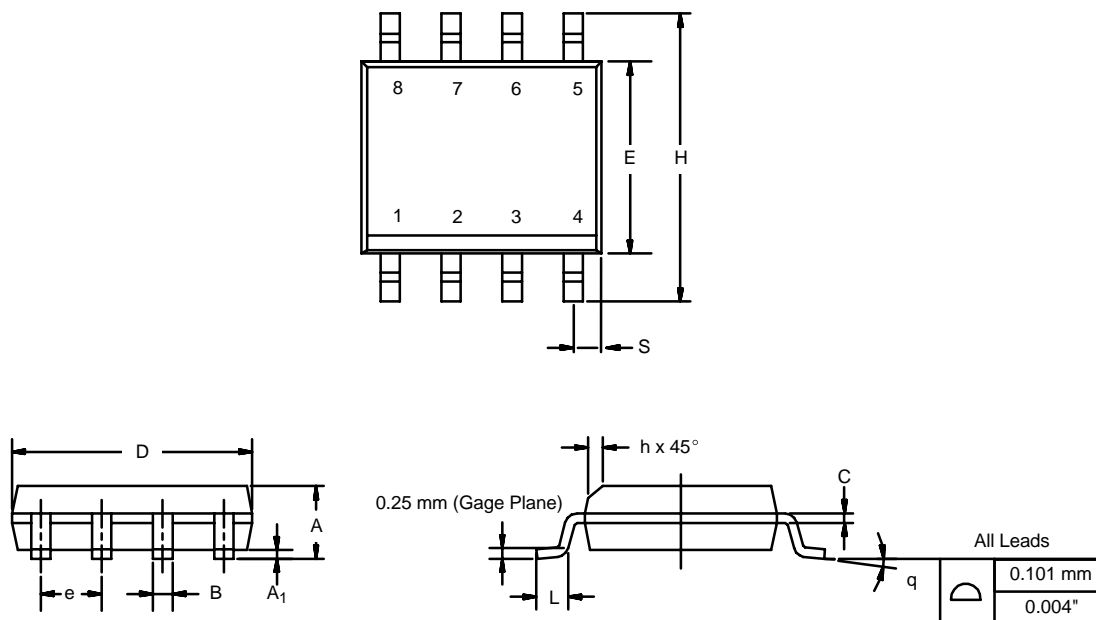


**Safe Operating Area, Junction-to-Case**
