

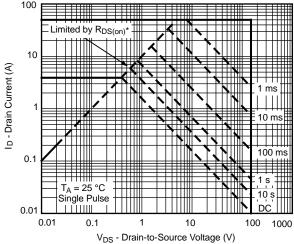

Single Pulse Power, Junction-to-Ambient






T_C - Case Temperature (°C)










T_A - Ambient Temperature (°C) **Power, Junction-to-Ambient**




Normalized Thermal Transient Impedance, Junction-to-Ambient

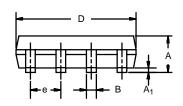


Normalized Thermal Transient Impedance, Junction-to-Foot
