



### TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted







#### TYPICAL CHARACTERISTICS 25 C, unless otherwise noted








On-Resistance vs. Gate-to-Source Voltage




Single Pulse Power, Junction-to-Ambient




Safe Operating Area, Junction-to-Foot


Normalized Thermal Transient Impedance, Junction-to-Ambient




Normalized Thermal Transient Impedance, Junction-to-Foot

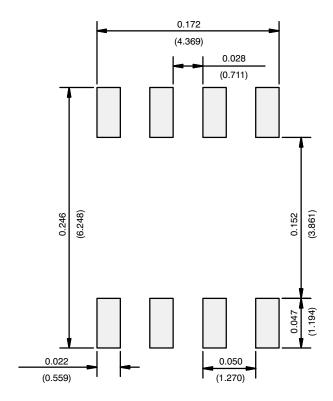
