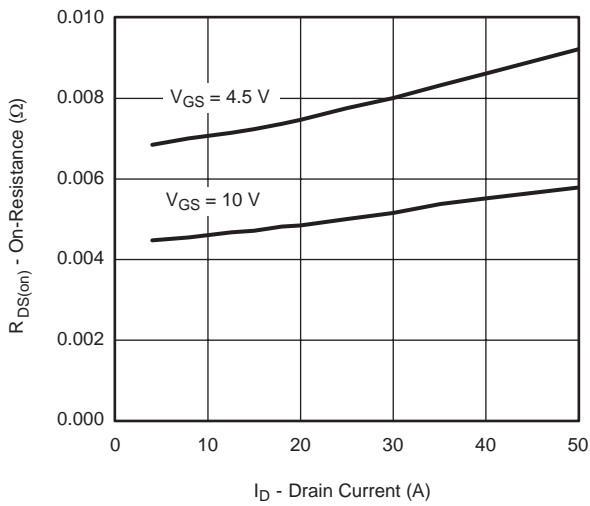

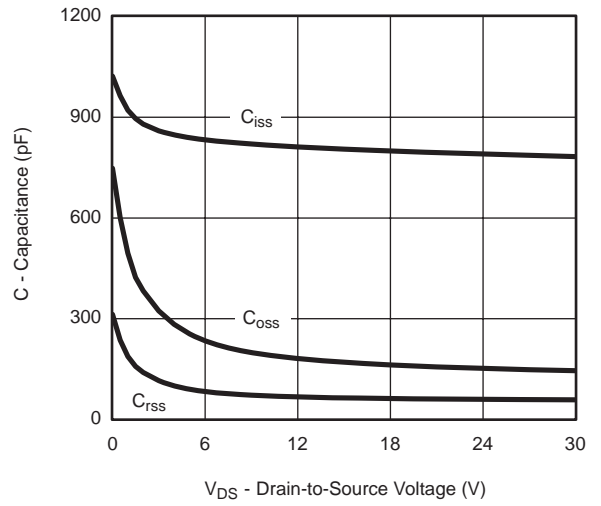

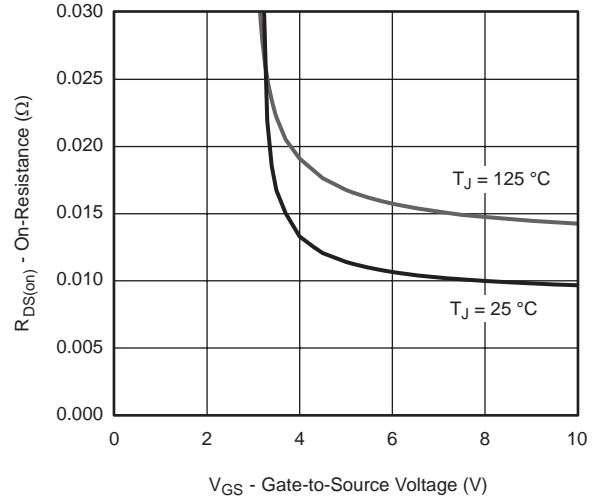


**On-Resistance vs. Junction Temperature**

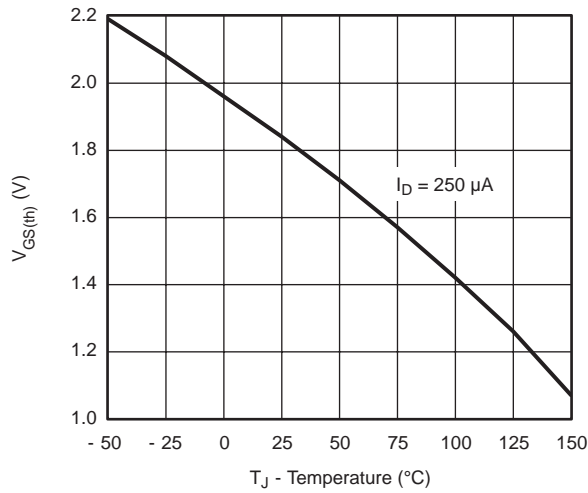

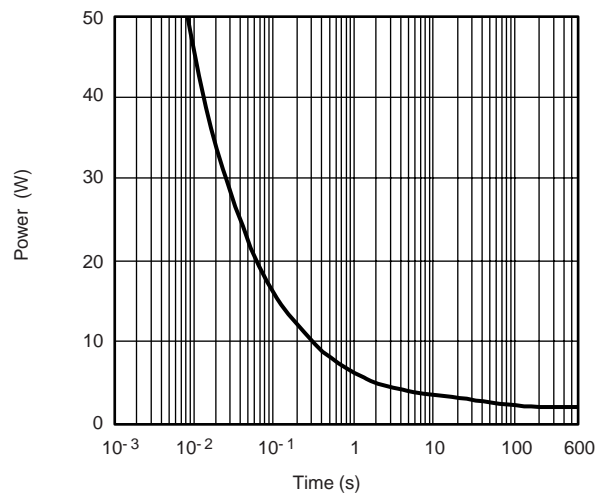
**Source-Drain Diode Forward Voltage**

**Threshold Voltage**



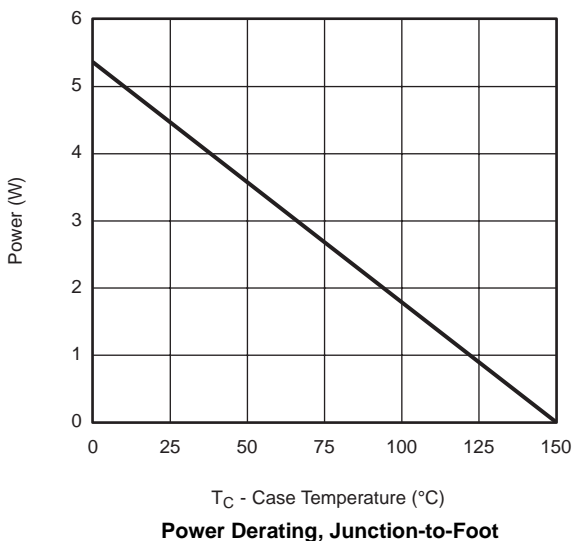
