
DESCRIPTION

The PS2533-1 and PS2533L-1 are optically coupled isolator containing a GaAs light emitting diode and an NPN silicon darlington connected phototransistor.

The PS2533-1 is in a plastic DIP (Dual In-line Package) and the PS2533L-1 is lead bending type (Gull-wing) for surface mount.





Lead Bending Type For Surface Mount













COLLECTOR TO EMITTER DARK CURRENT Vs. AMBIENT TEMPERATURE






COLLECTOR CURRENT vs. COLLECTOR TO EMITTER VOLTAGE




COLLECTOR CURRENT vs. COLLECTOR SATURATION VOLTAGE




NORMALIZED CURRENT TRANSFER RATIO vs. AMBIENT TEMPERATURE




SWITCHING TIME vs. LOAD RESISTANCE



CURRENT TRANSFER RATIO vs. FORWARD CURRENT













Outline and Dimensions (Tape)



- 3. Measurement conditions of current transfer ratios (CTR), which differ according to photocoupler Check the setting values before use, since the forward current conditions at CTR measurement differ according to product.

When using products other than at the specified forward current, the characteristics curves may differ from the standard curves due to CTR value variations or the like. Therefore, check the characteristics under the actual operating conditions and thoroughly take variations or the like into consideration before use.





Dependence of maximum safety ratings with package temperature




Method a) Destructive Test, Type and Sample Test
