## DESCRIPTION/ORDERING INFORMATION

This dual analog switch is operational at $0.8-\mathrm{V}$ to $2.7-\mathrm{V} \mathrm{V}_{\mathrm{CC}}$, but is designed specifically for $1.1-\mathrm{V}$ to $2.7-\mathrm{V} \mathrm{V}_{\mathrm{CC}}$ operation.

The SN74AUC2G66 can handle both analog and digital signals. It permits signals with amplitudes of up to $2.7-\mathrm{V}$ (peak) to be transmitted in either direction.

NanoFree ${ }^{\text {TM }}$ package technology is a major breakthrough in IC packaging concepts, using the die as the package.
Applications include signal gating, chopping, modulation or demodulation (modem), and signal multiplexing for analog-to-digital and digital-to-analog conversion systems.
