







Current Rating Thermal Derating Curve



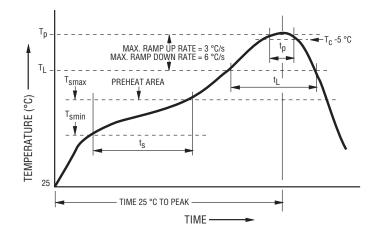



Recommended Temperature Profile for Wave Soldering






