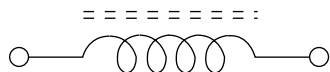

Electrical Schematic

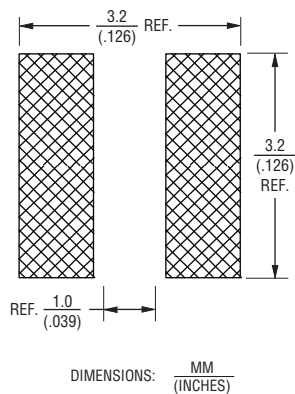
