





Fig. 7. Test circuit for measuring switching times

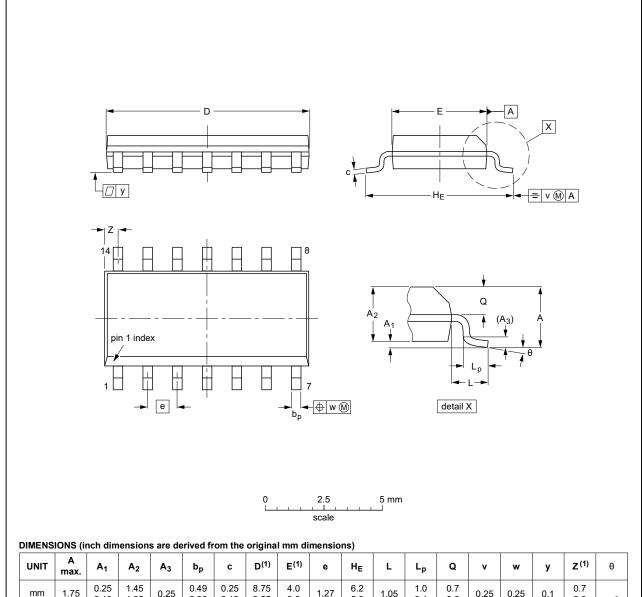


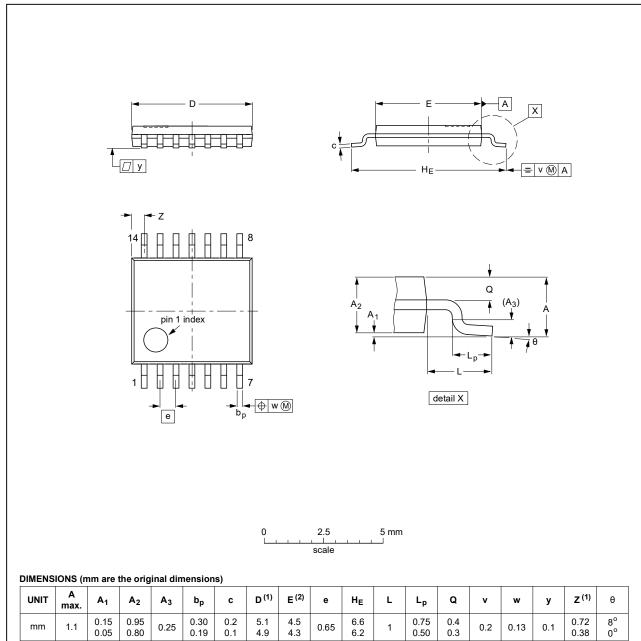


Fig. 9. Package outline SOT337-1 (SSOP14)

Fig. 10. Package outline SOT402-1 (TSSOP14)




Fig. 11. Package outline SOT762-1 (DHVQFN14)
