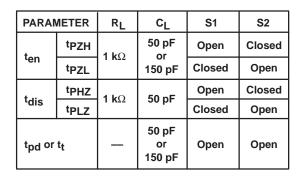

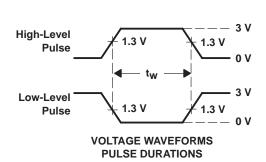

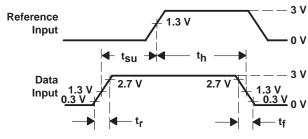

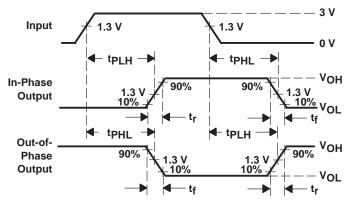


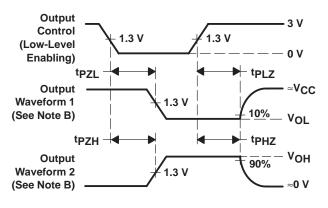






VOLTAGE WAVEFORMS
