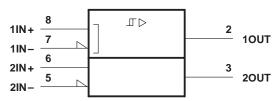

# description

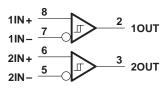

# logic diagram

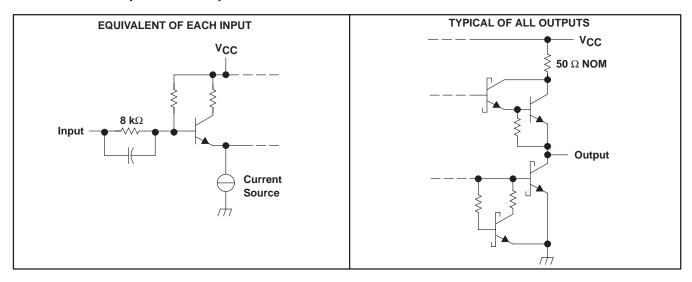

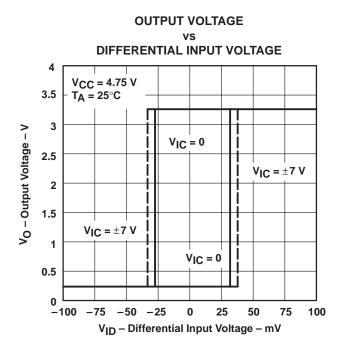

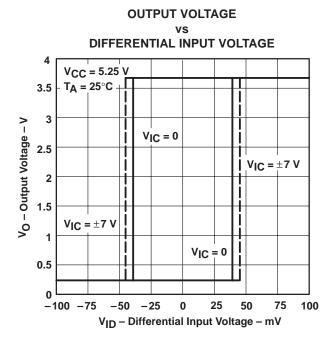

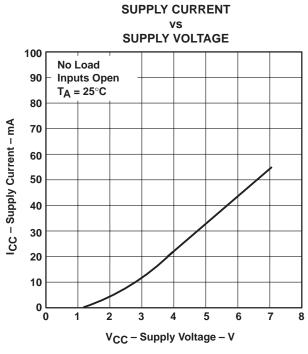

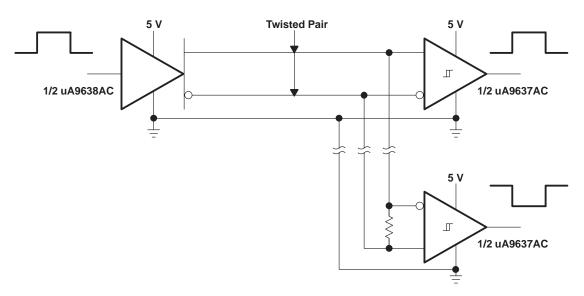


Figure 7. EIA/TIA-422-B System Applications

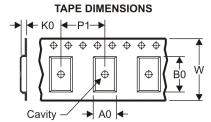

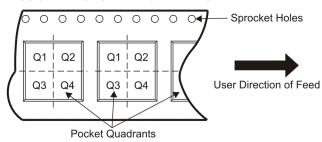
