




TYPICAL CHARACTERISTICS (25 °C, unless otherwise noted)













 V_{GS} - Gate-to-Source Voltage (V)


 $R_{DS(on)}$ vs. V_{GS} vs. Temperature







TO-252AA CASE OUTLINE






