




On-Resistance vs. Drain Current








On-Resistance vs. Junction Temperature










### **Source Drain Diode Forward Voltage**


On-Resistance vs. Gate-to Source Voltage





### **Threshold Voltage**




**Drain Source Breakdown vs. Junction Temperature**




Safe Operating Area



Normalized Thermal Transient Impedance, Junction-to-Case










