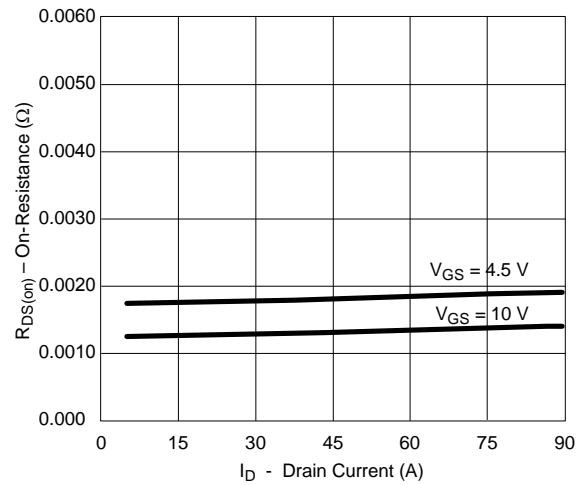

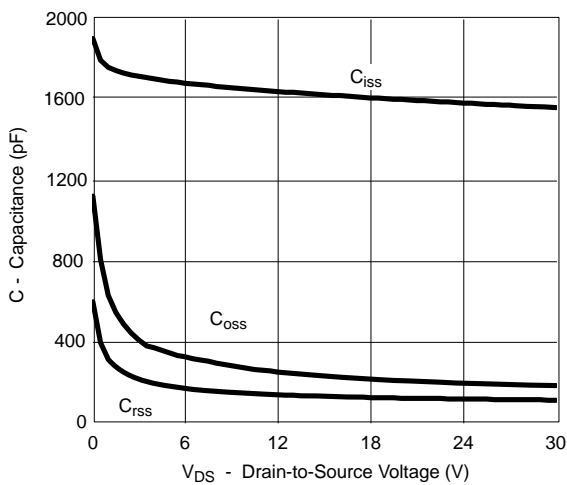

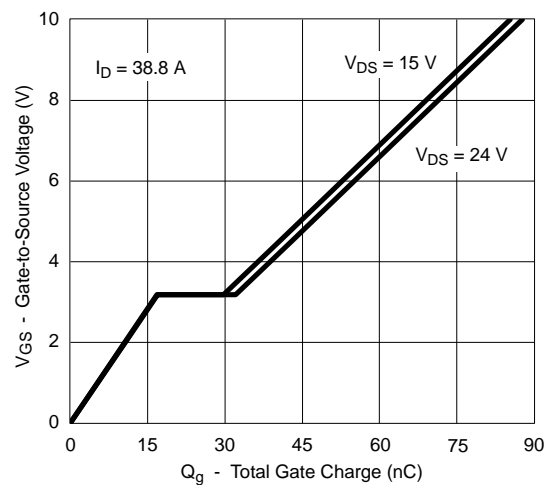
Transconductance



$R_{DS(on)}$ vs. Drain Current

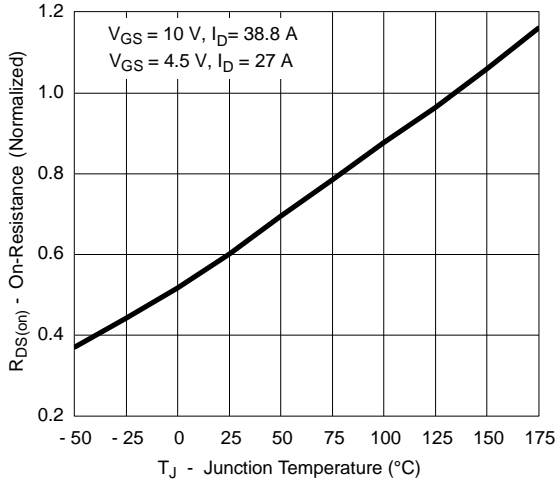


Capacitance

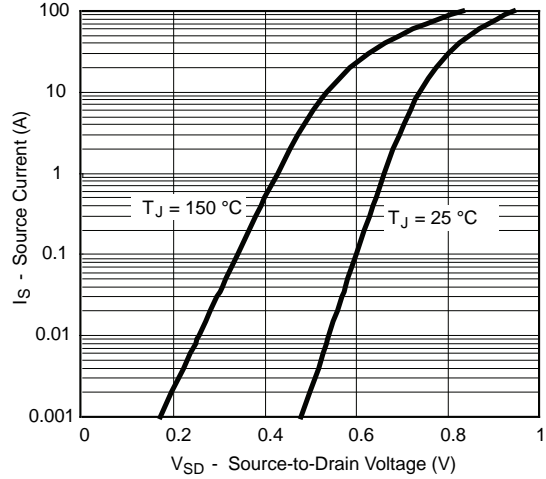


Gate Charge

R_{DS(on)} vs. V_{GS} vs. Temperature

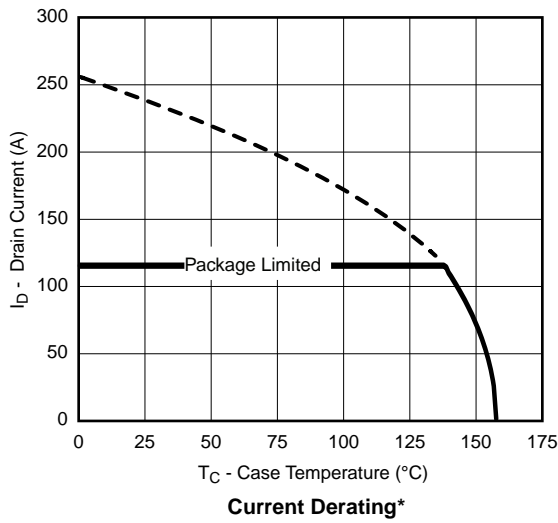


Threshold Voltage

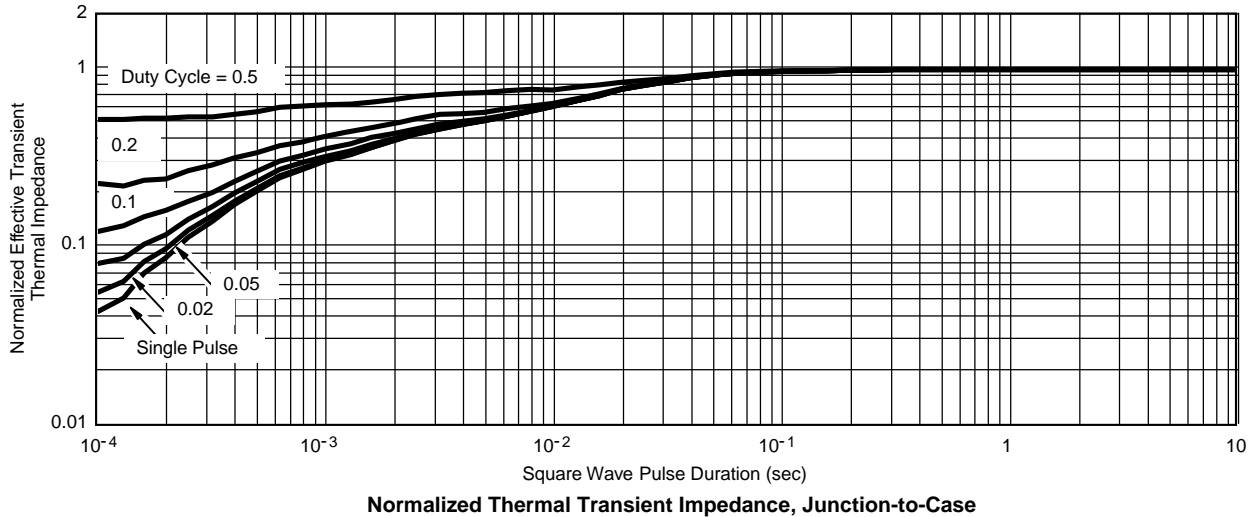
