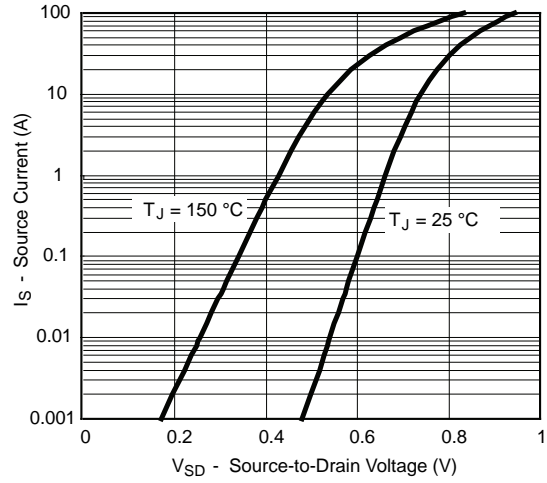

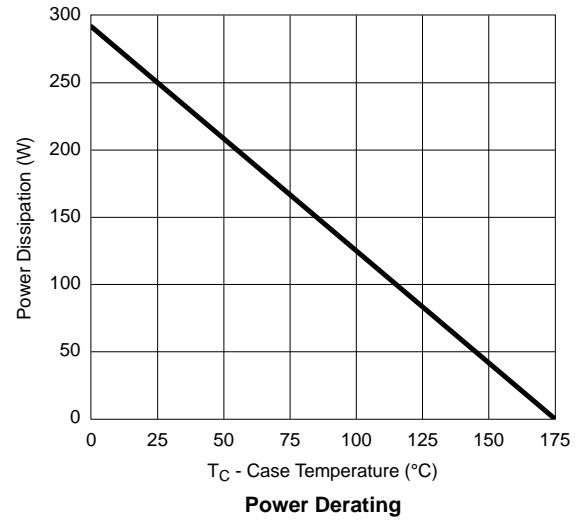
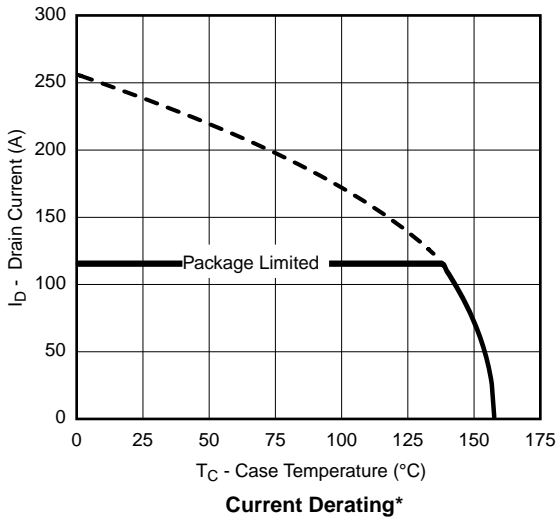


Threshold Voltage
