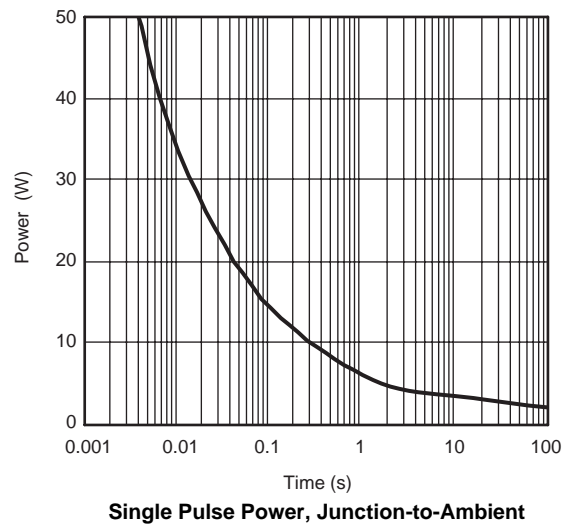
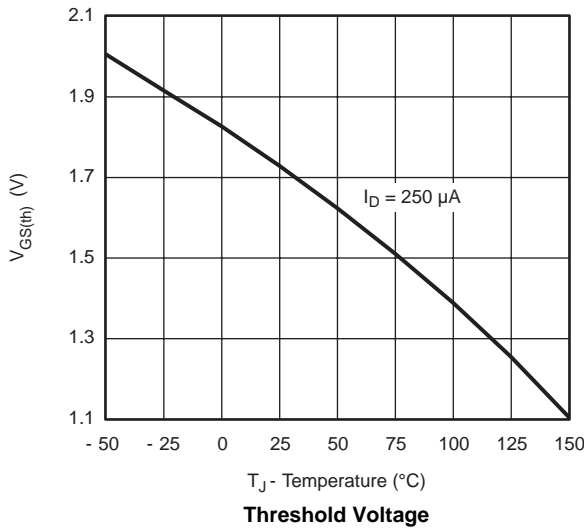
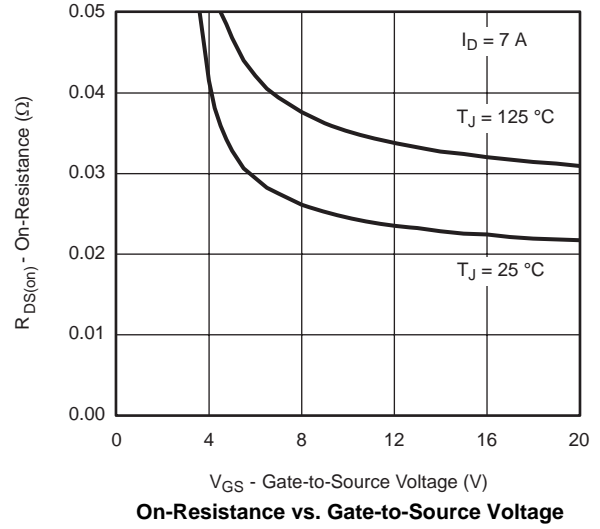


Gate Charge



On-Resistance vs. Junction Temperature

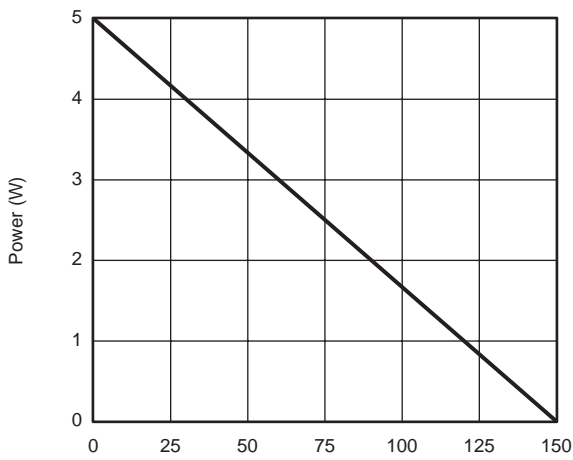

Power, Junction-to-Foot



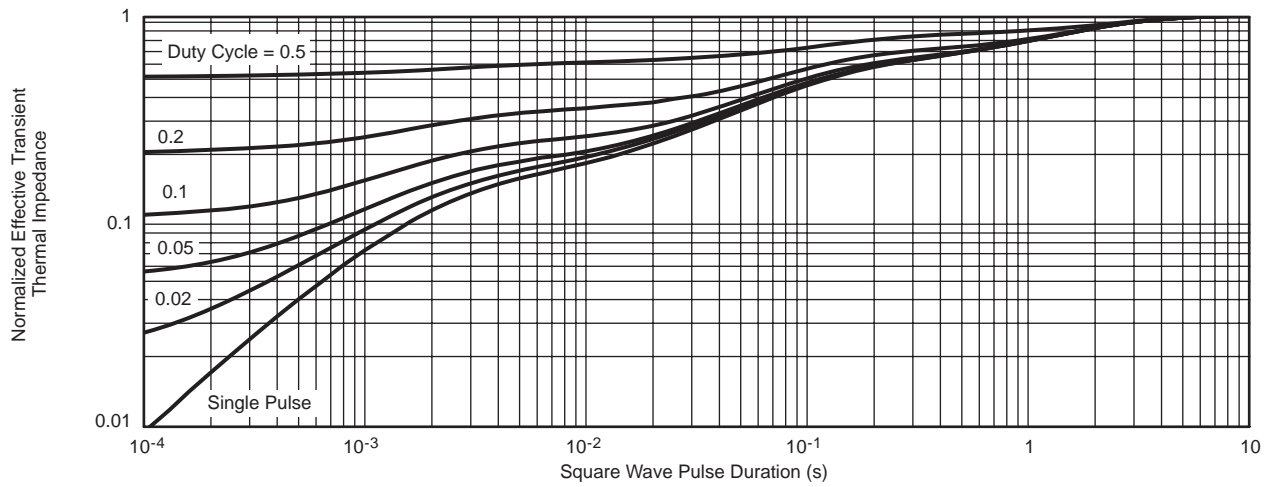

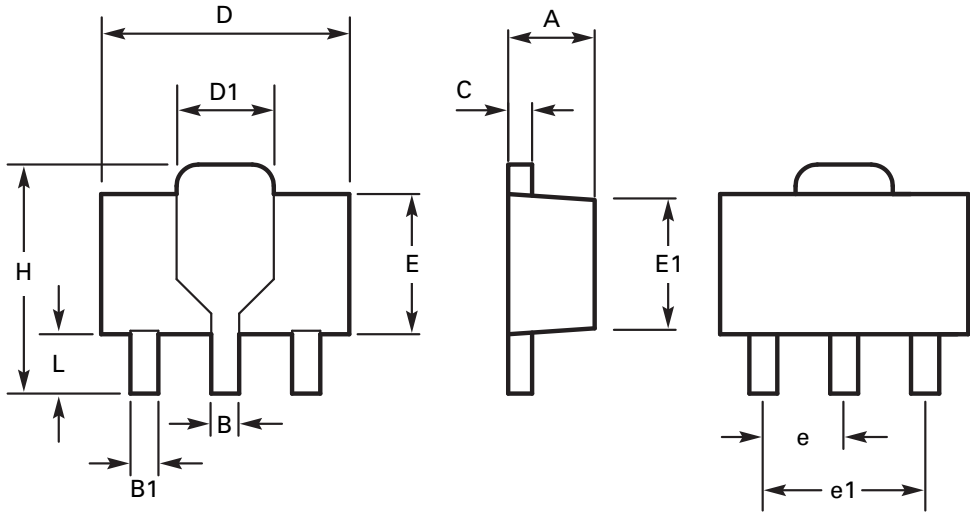


Normalized Thermal Transient Impedance, Junction-to-Ambient
