




### On-Resistance vs. Drain Current







#### **On-Resistance vs. Junction Temperature**




T<sub>J</sub> - Junction Temperature (°C)





### **Source Drain Diode Forward Voltage**


On-Resistance vs. Gate-to-Source Voltage






Safe Operating Area

#### Normalized Thermal Transient Impedance, Junction-to-Case




