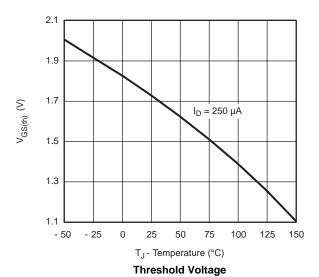






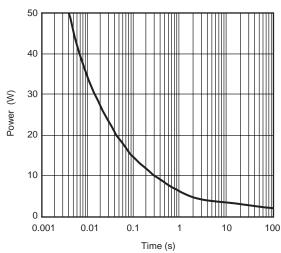


Source-Drain Diode Forward Voltage

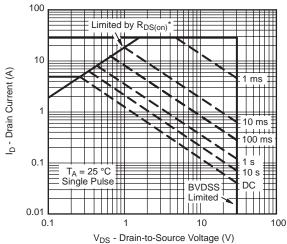

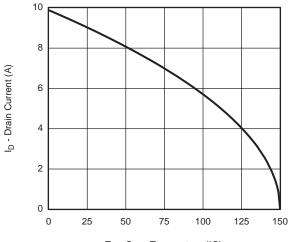
Single Pulse Power, Junction-to-Ambient

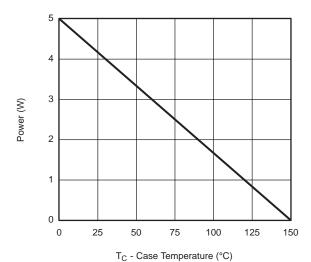
Safe Operating Area



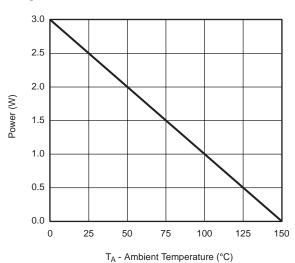


T_C - Case Temperature (°C)

Current Derating*



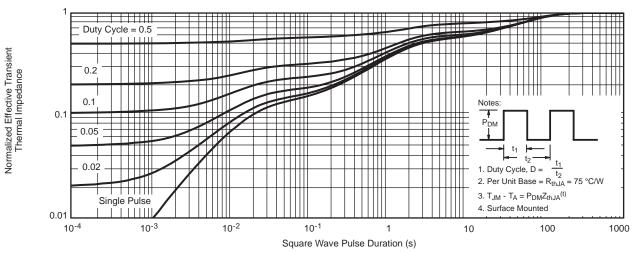
Power, Junction-to-Foot



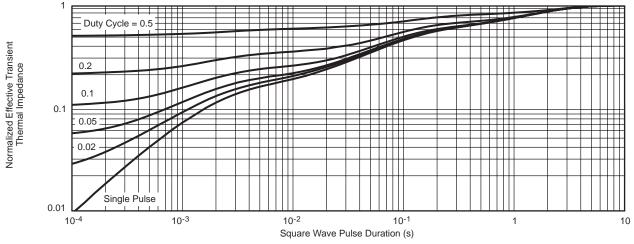

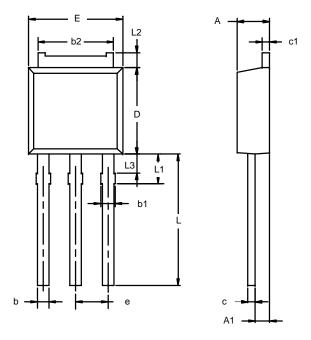
Normalized Thermal Transient Impedance, Junction-to-Ambient
