



### TYPICAL CHARACTERISTICS (25 °C, unless otherwise noted)



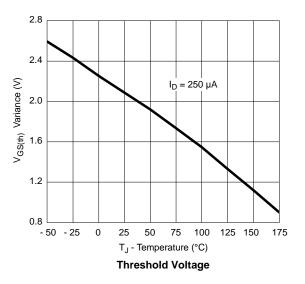










Forward Diode Voltage vs. Temperature











