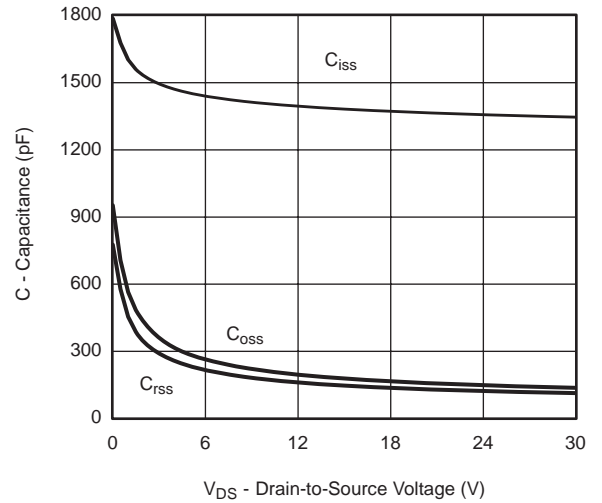

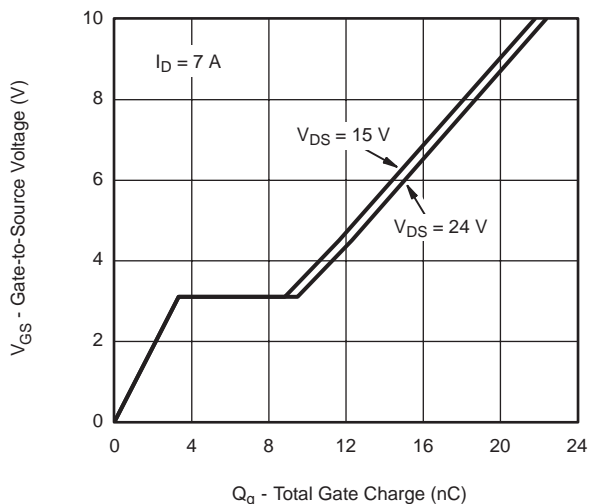

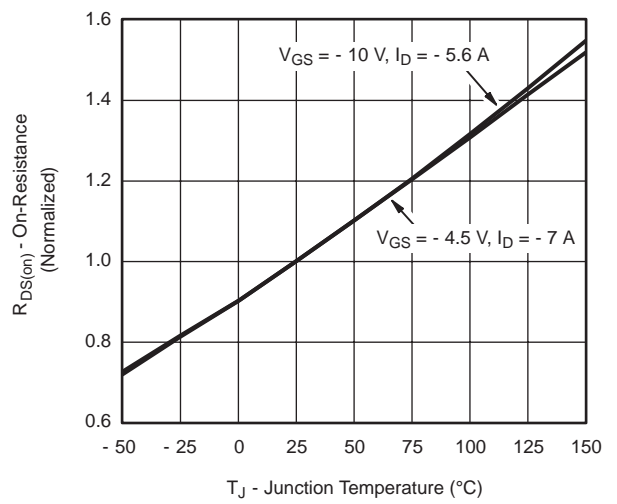
On-Resistance vs. Drain Current

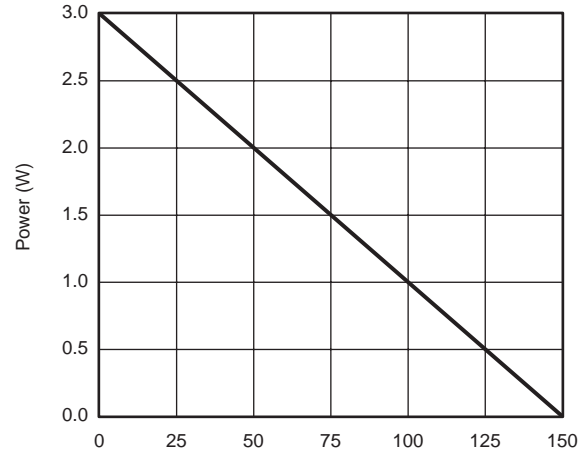

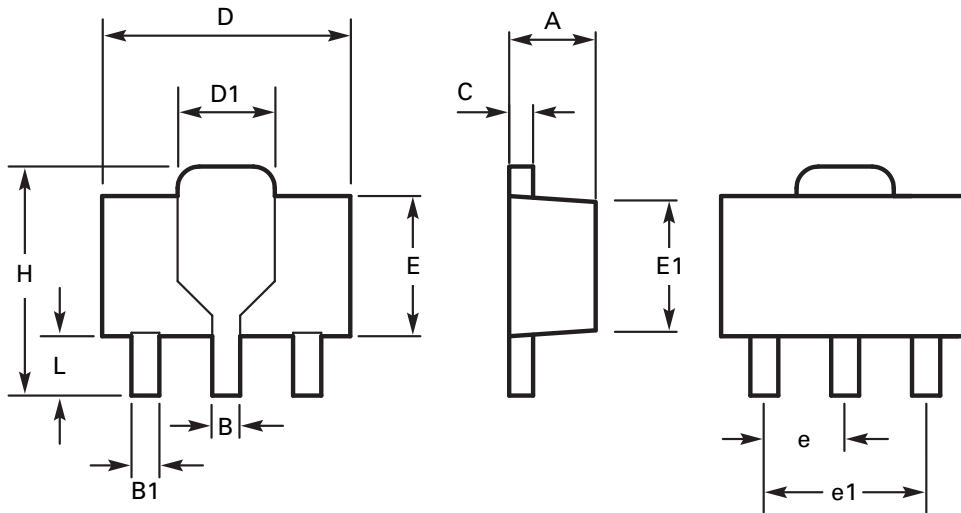


Normalized Thermal Transient Impedance, Junction-to-Ambient
