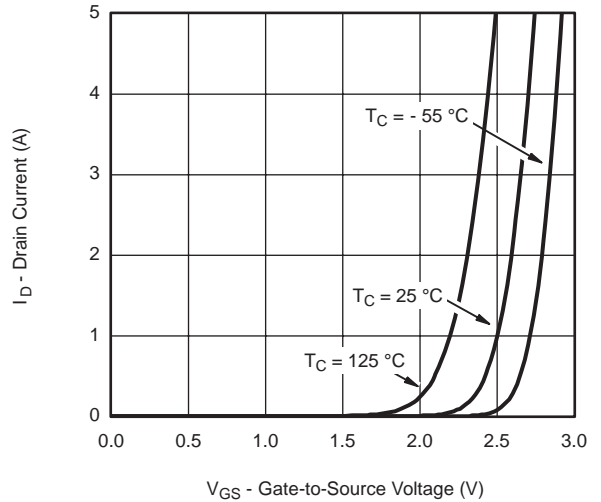

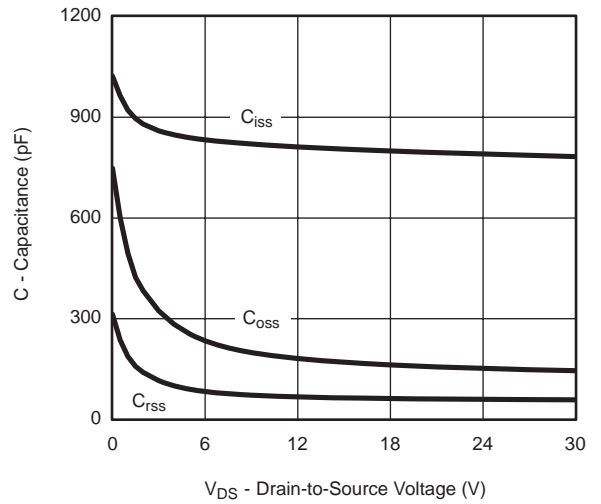

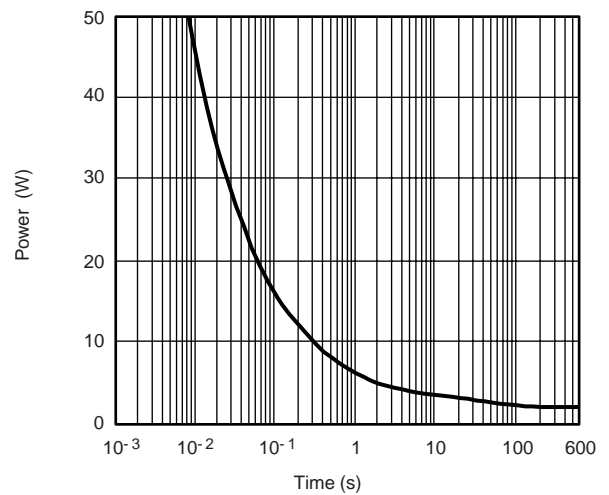
**Source-Drain Diode Forward Voltage**

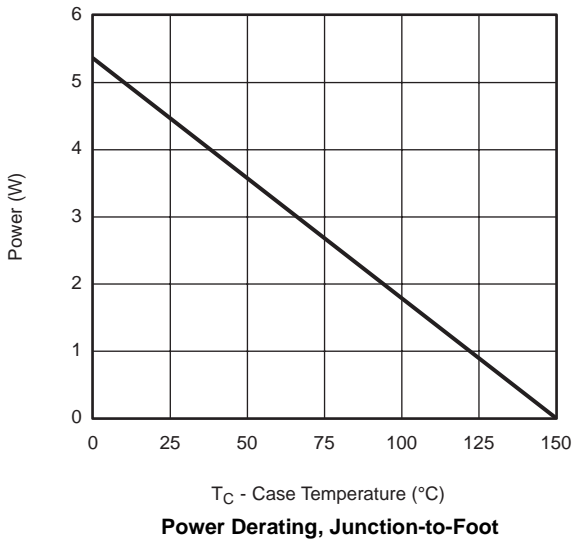
