
# TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted











#### Source-Drain Diode Forward Voltage




On-Resistance vs. Gate-Source Voltage



# **Threshold Voltage Variance Over Temperature**






Normalized Thermal Transient Impedance, Junction-to-Ambient




