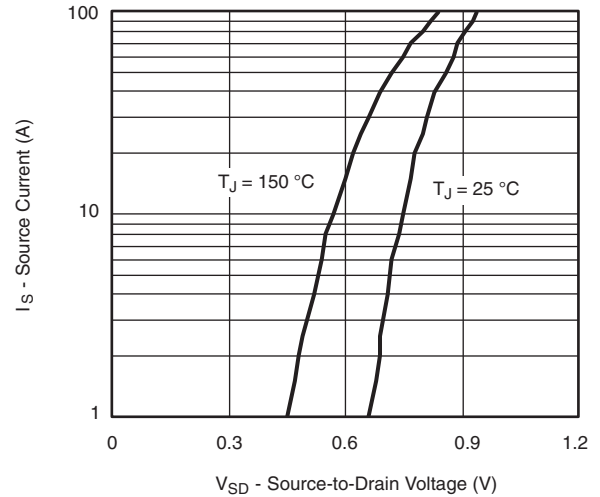

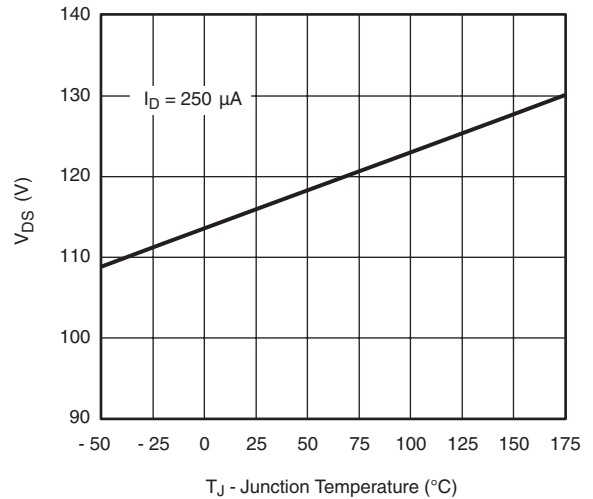
On-Resistance vs. Junction Temperature



Source-Drain Diode Forward Voltage

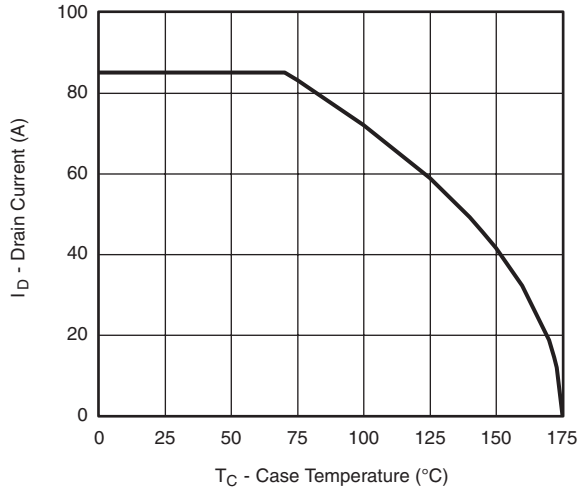


Avalanche Current vs. Time

Maximum Avalanche and Drain Current vs. Case Temperature

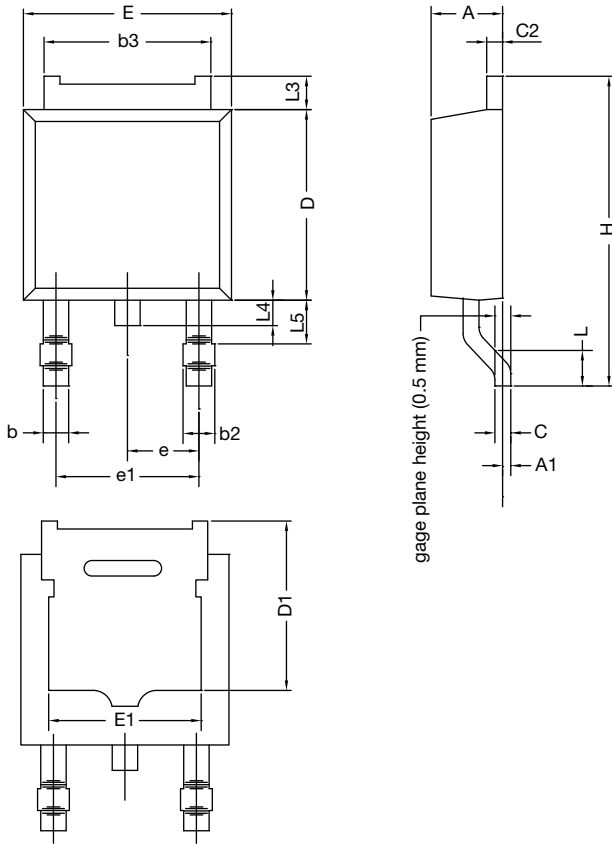


Safe Operating Area

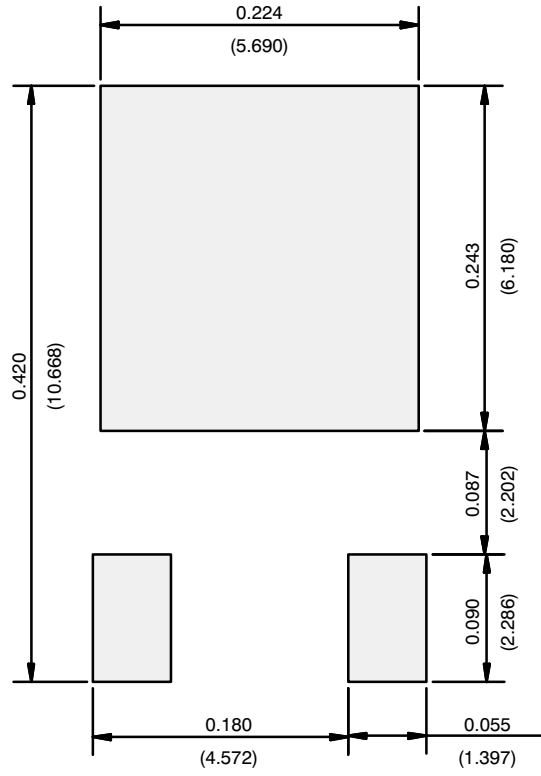
