


Radiation Characteristics 7), 8)

 $I_{e,rel} = f(\phi)$





Relative Total Radiant Flux ^{7), 8)}




Max. Permissible Forward Current


Permissible Pulse Handling Capability



Tape and Reel ¹⁰⁾




