

Figure 5 Gain-Bandwidth Product vs. Collector Current



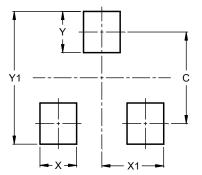
