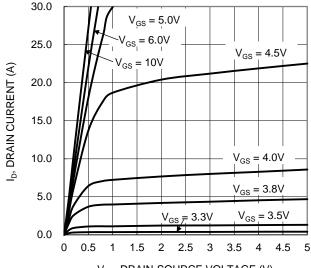

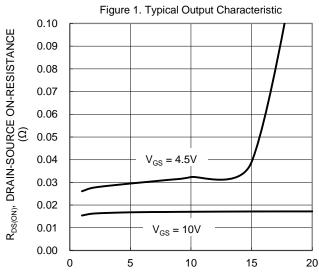

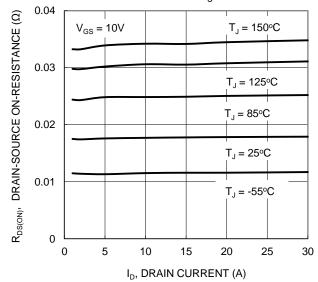
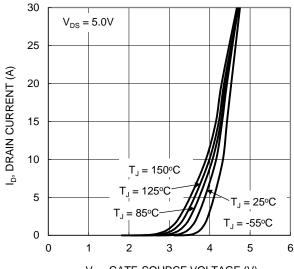


Figure 5. Typical On-Resistance vs. Drain Current and Temperature



 $V_{\text{GS}}$ , GATE-SOURCE VOLTAGE (V)

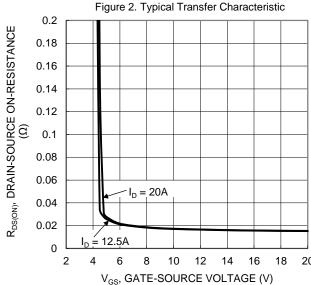
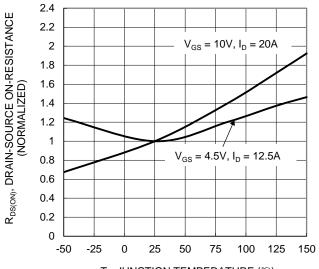


Figure 4. Typical Transfer Characteristic







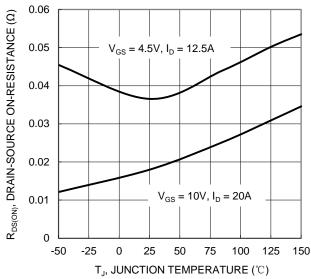
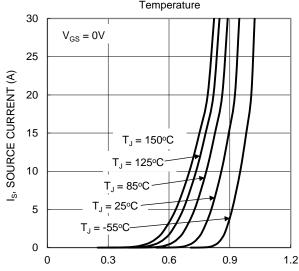


Figure 7. On-Resistance Variation with Temperature

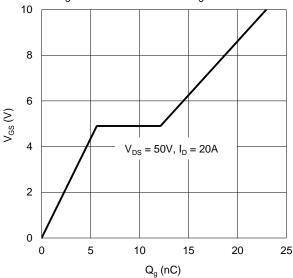


Figure 11. Gate Charge

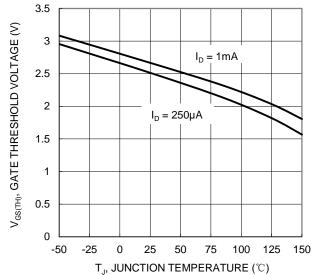
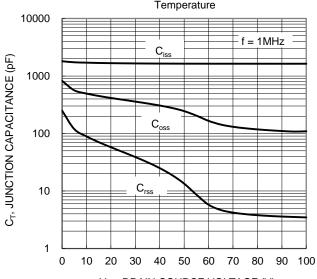
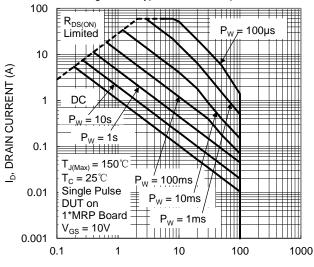


Figure 8. Gate Threshold Variation vs.

V<sub>DS</sub>, DRAIN-SOURCE VOLTAGE (V) Figure 12. SOA, Safe Operation Area



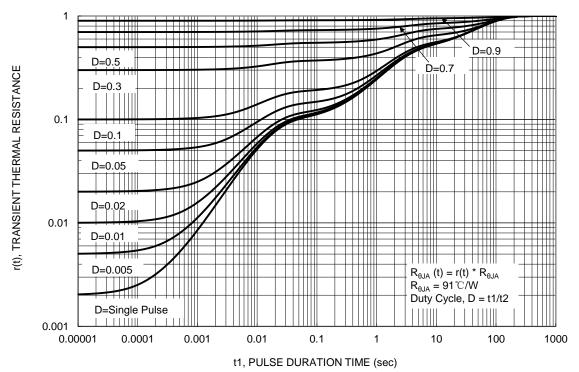


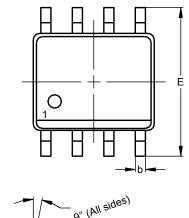
Figure 13. Transient Thermal Resistance

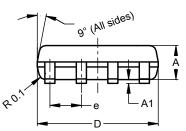


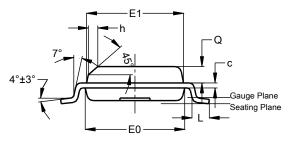

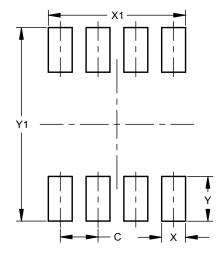
