1. General description

The 74HCU04-Q100 is a hex unbuffered inverter. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess of $V_{\rm CC}$.

This product has been qualified to the Automotive Electronics Council (AEC) standard Q100 (Grade 1) and is suitable for use in automotive applications.









The input (nA) to output (nY) propagation delay Fig. 6. times











Fig. 11. Test set-up for measuring forward transconductance


Fig. 12. Typical forward transconductance as a function of the supply voltage



Fig. 14. Crystal oscillator





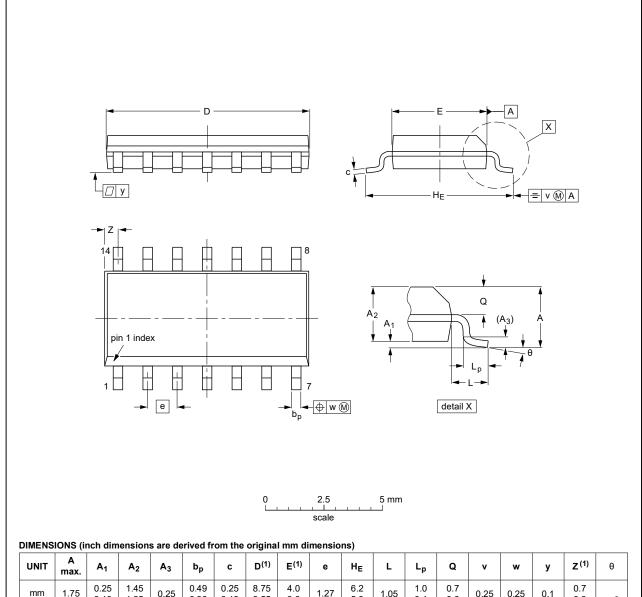



Fig. 18. Package outline SOT402-1 (TSSOP14)




Fig. 19. Package outline SOT762-1 (DHVQFN14)
