1. General description

The HEF4001B-Q100 is a quad 2-input NOR gate. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess of V_{DD} .

This product has been qualified to the Automotive Electronics Council (AEC) standard Q100 (Grade 1) and is suitable for use in automotive applications.

 - Specified from -40 °C to +85 °C and from -40 °C to +125 °C
- Wide supply voltage range from 3.0 V to 15.0 V

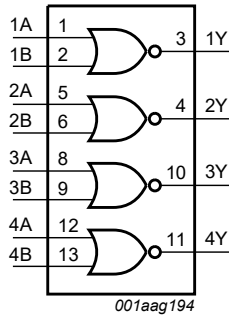


Fig. 1. Functional diagram

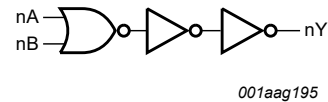


Fig. 2. Logic diagram (one gate)

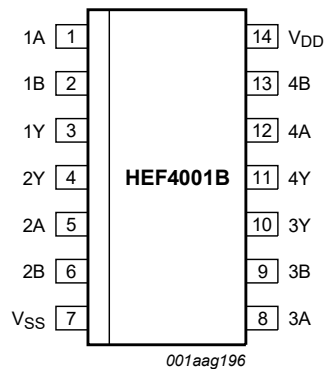


Fig. 3. Pin configuration SOT108-1 (SO14)

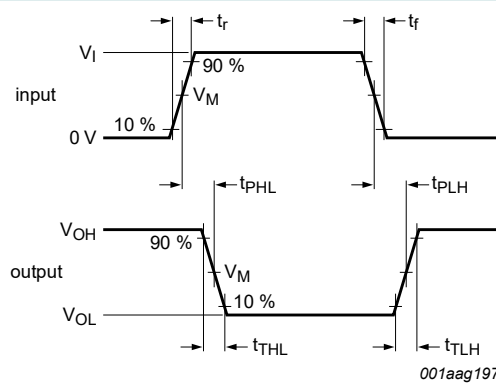

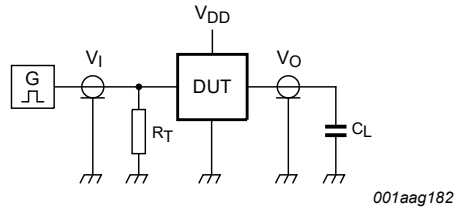

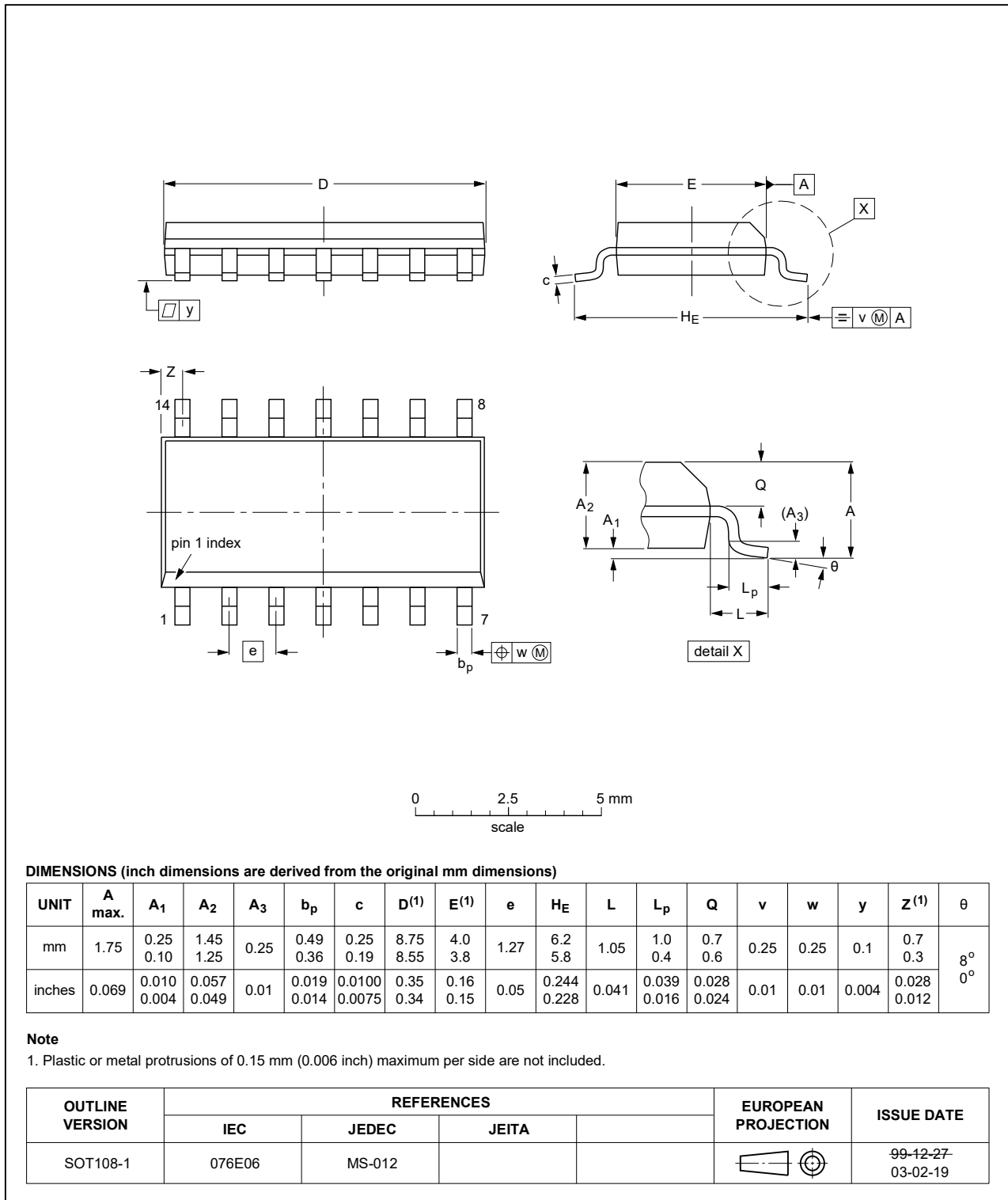


Fig. 6. Package outline SOT108-1 (SO14)
