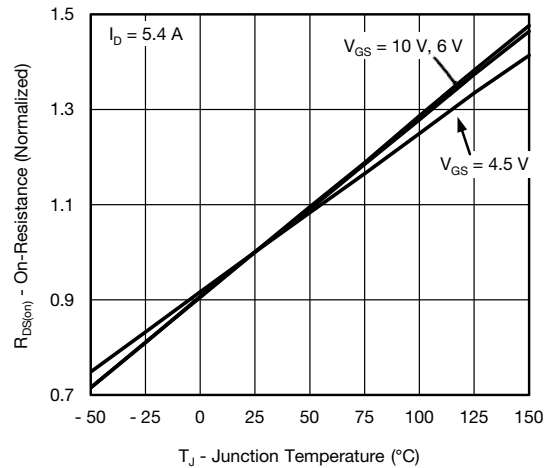

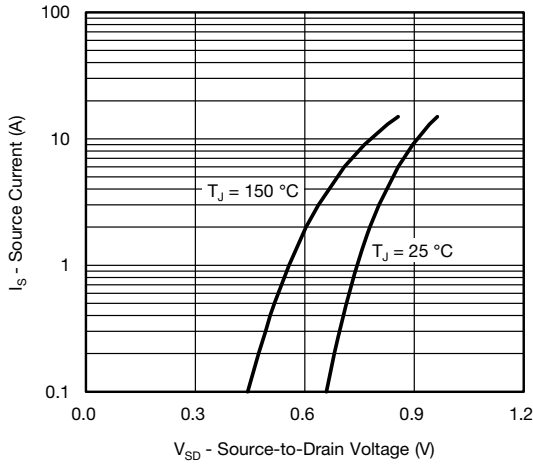

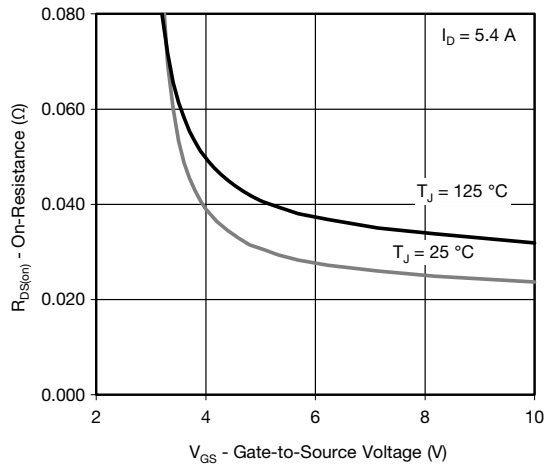


**On-Resistance vs. Junction Temperature**

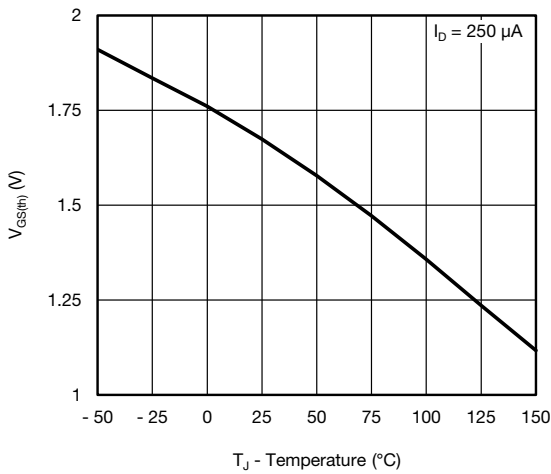

**Source-Drain Diode Forward Voltage**



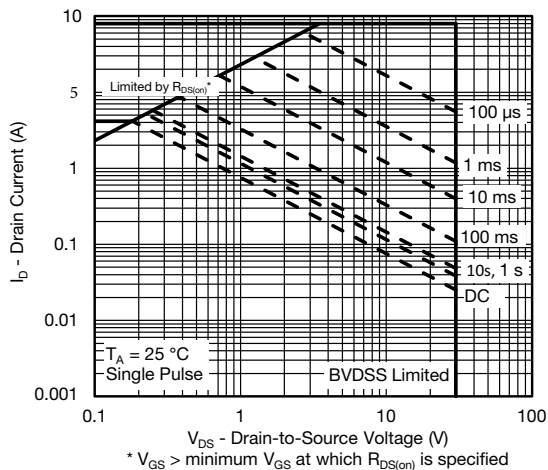
**On-Resistance vs. Gate-to-Source Voltage**

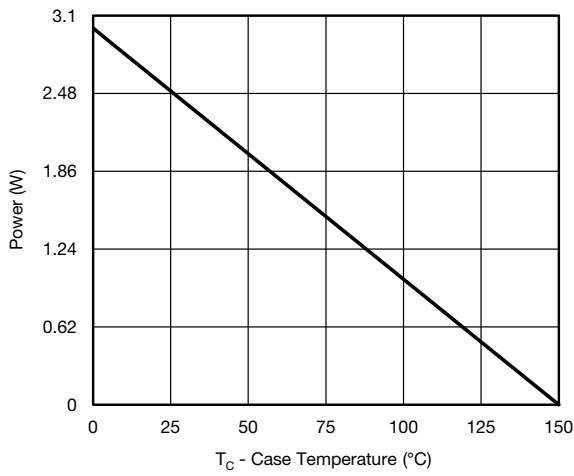

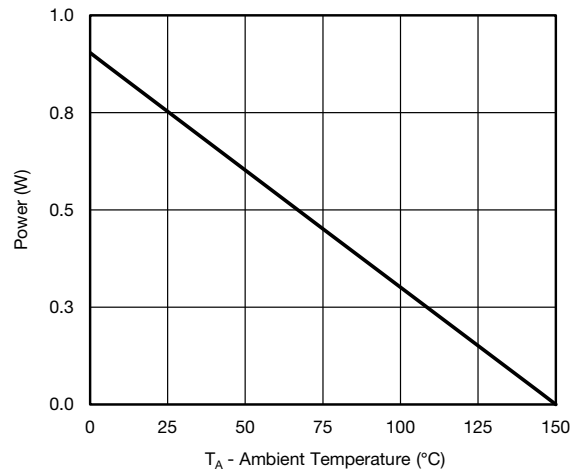

**Current Derating\***



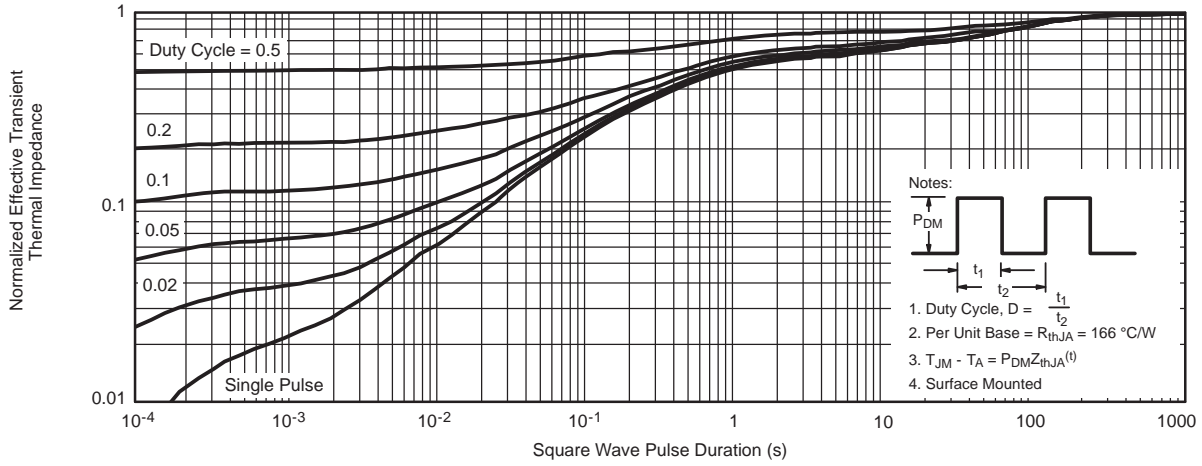
**Power, Junction-to-Foot**
