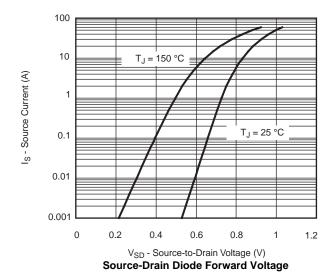

Single Pulse Power, Junction-to-Ambient

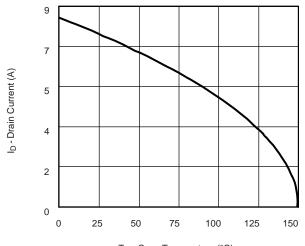

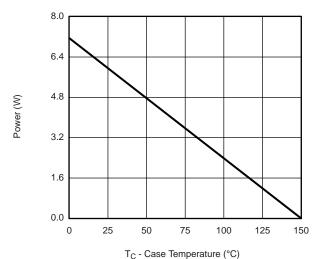
Safe Operating Area, Junction-to-Ambient

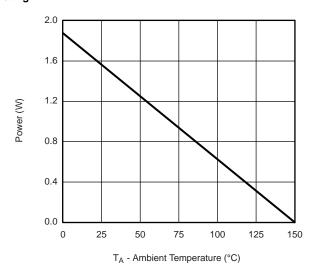

T_C - Case Temperature (°C) Current Derating*





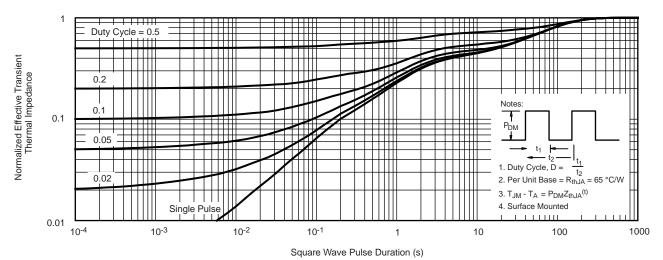

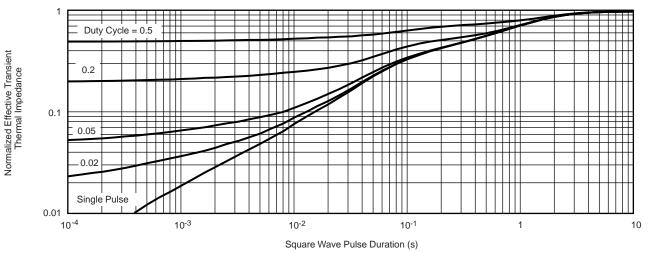

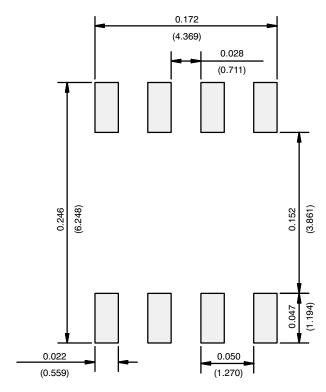
