









Gate Charge




Source-Drain Diode Forward Voltage




Single Pulse Avalanche Current Capability vs. Time










Threshold Voltage

T_J - Temperature (°C) Power Derating, Junction-to-Case








Normalized Thermal Transient Impedance, Junction-to-Case
