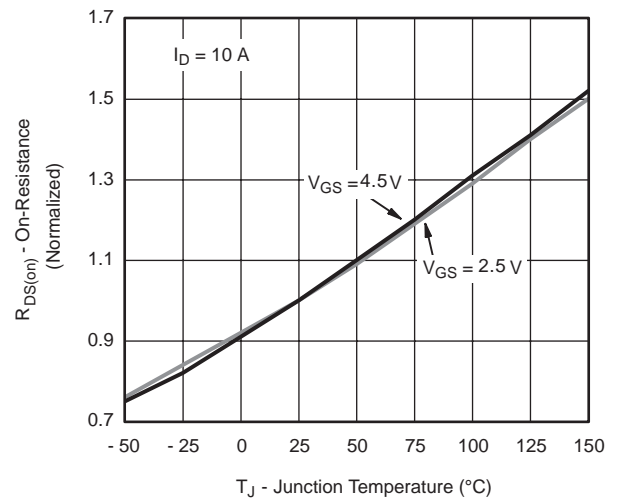
On-Resistance vs. Drain Current



Capacitance

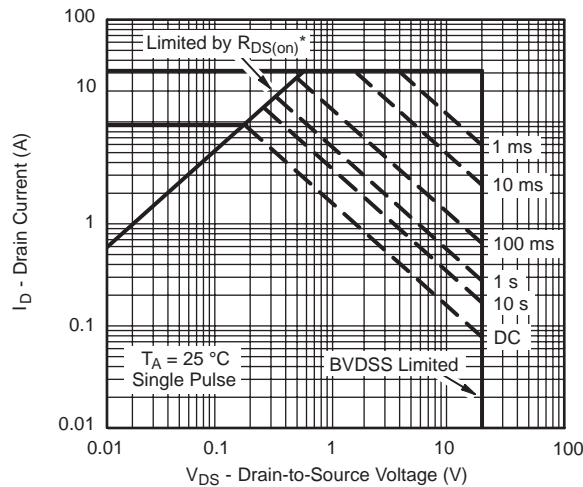
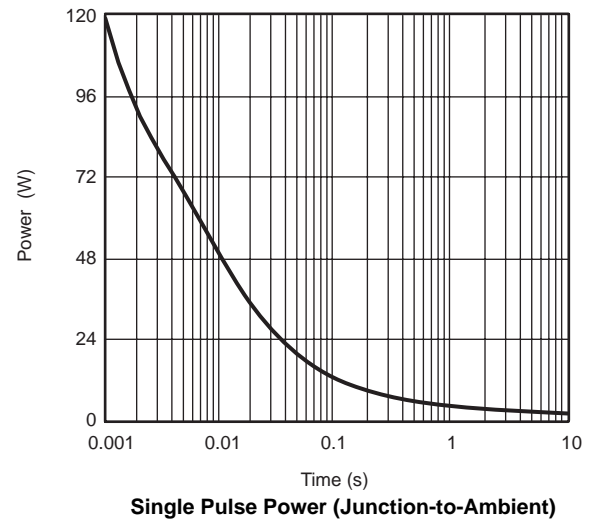
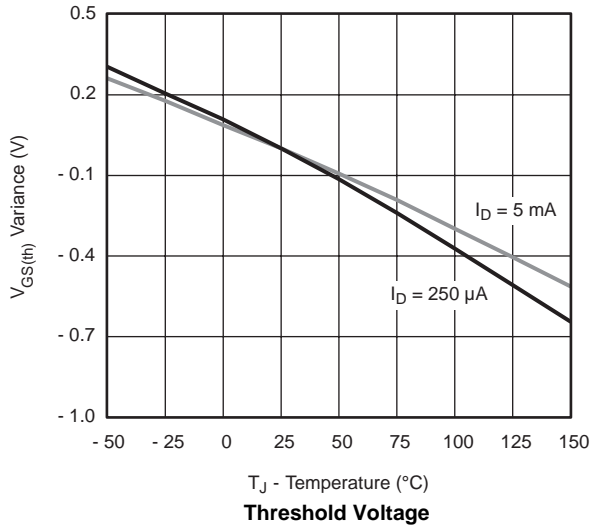
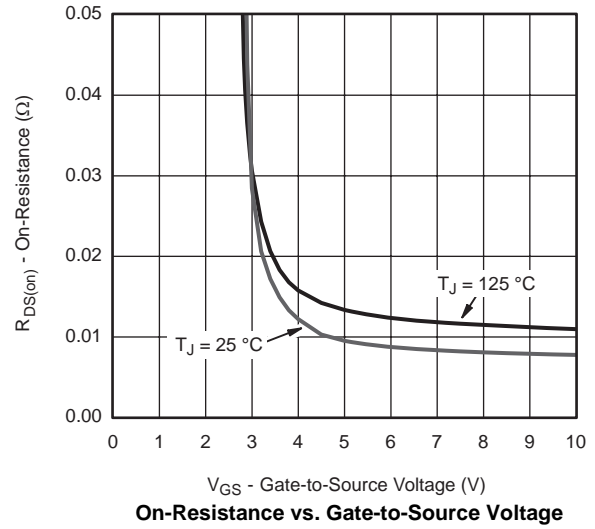
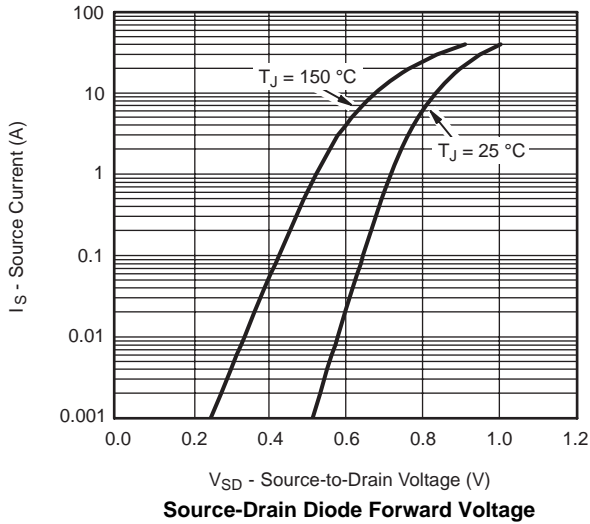


Gate Charge



On-Resistance vs. Junction Temperature

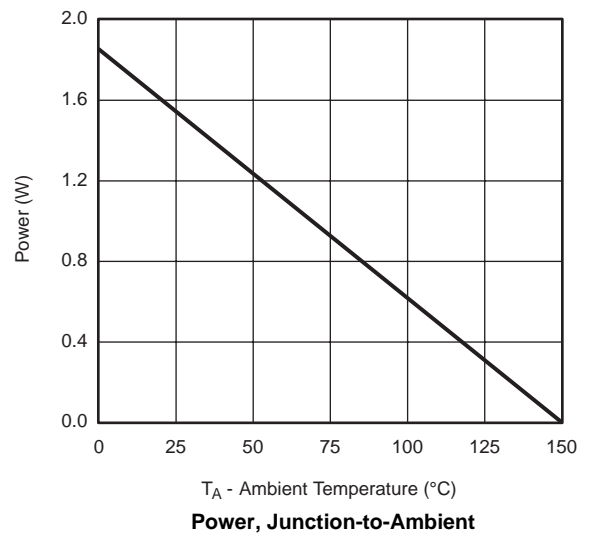
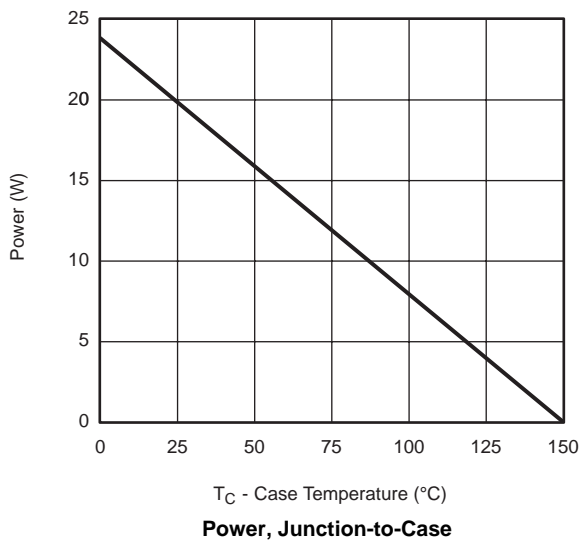
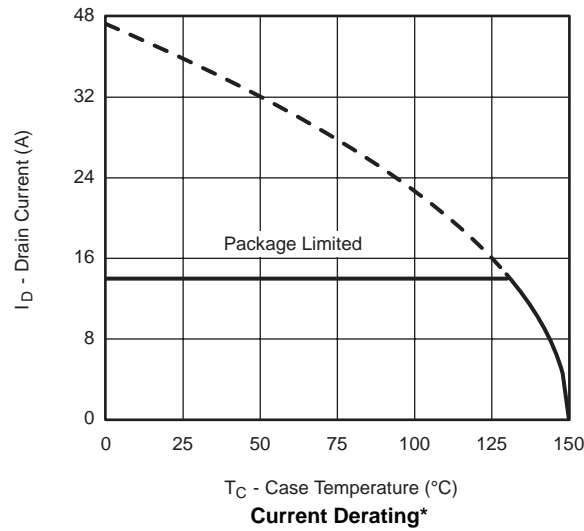

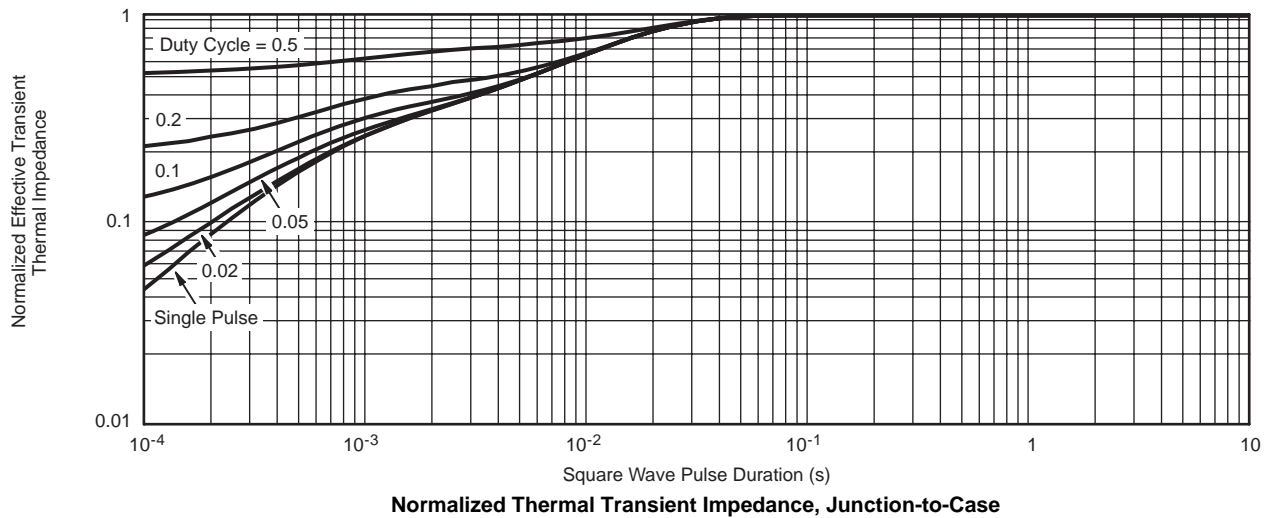
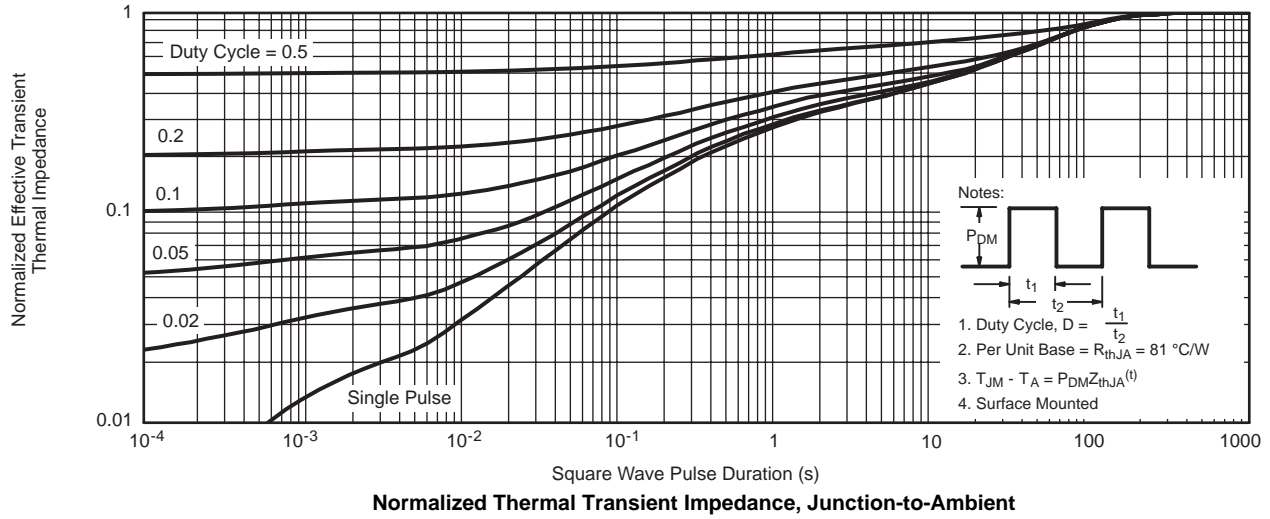
Safe Operating Area, Junction-to-Ambient
