



### TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted



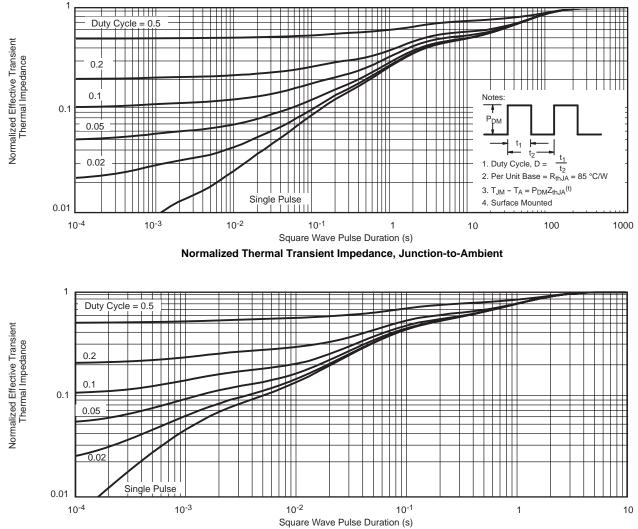
## MOSFET TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted

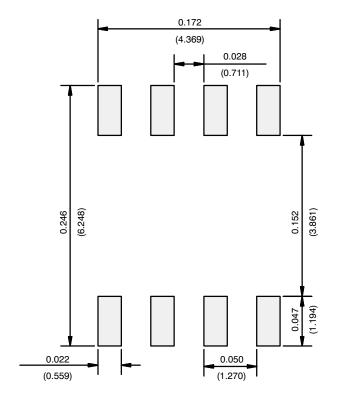
