


TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted







TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted




Source-Drain Diode Forward Voltage




On-Resistance vs. Gate-Source Voltage



 $T_{J} \mbox{ - Junction Temperature (°C)} \\$ Threshold Voltage Variance Over Temperature




Single Pulse Power, Junction-to-Ambient


Normalized Thermal Transient Impedance, Junction-to-Foot




