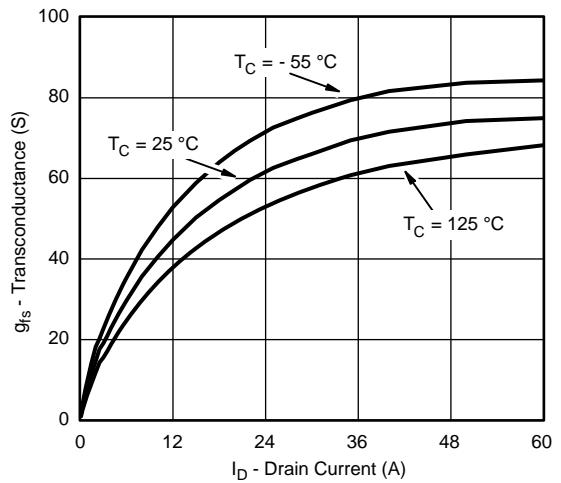

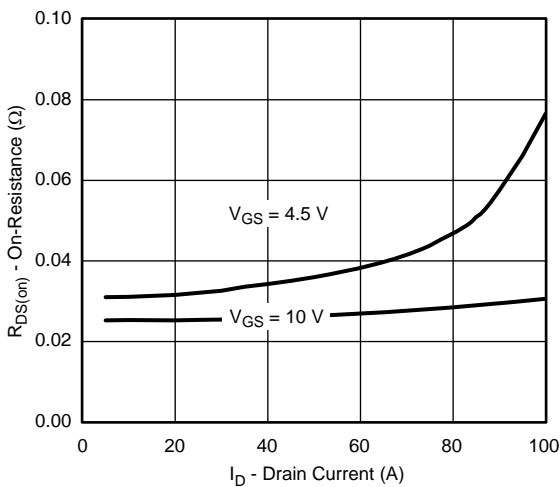

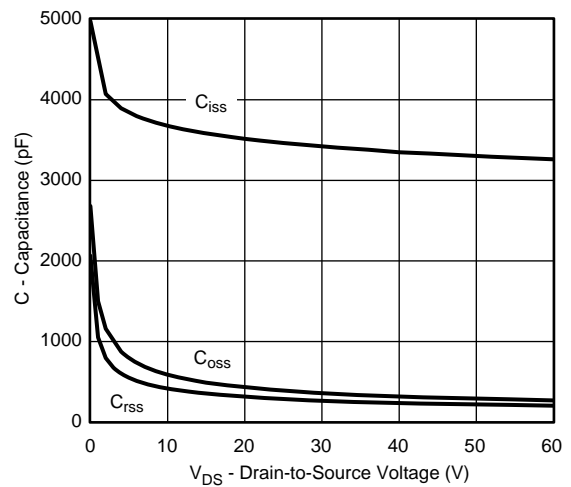

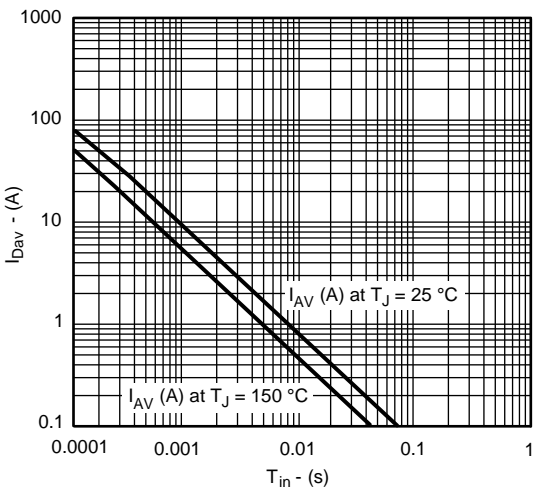
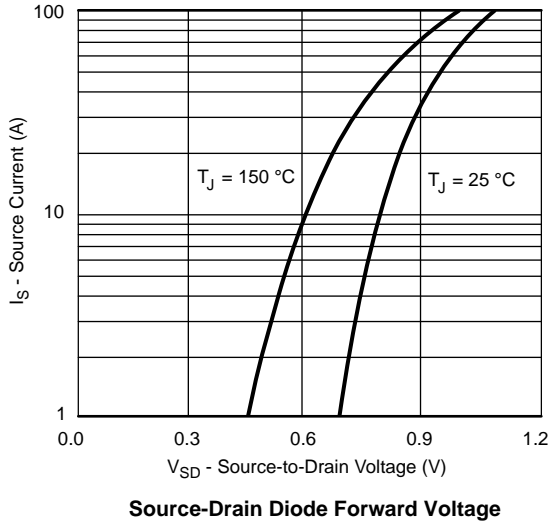
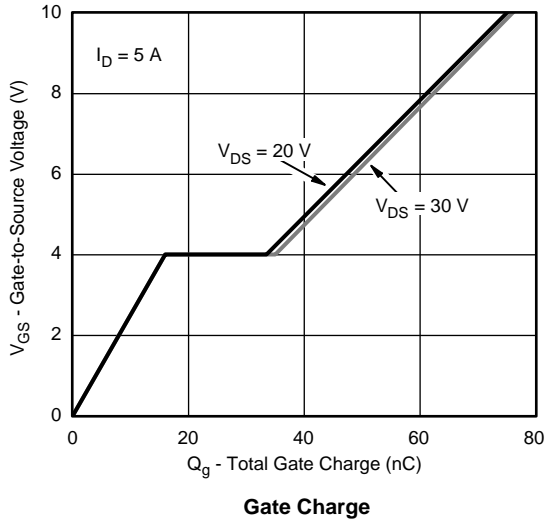


On-Resistance vs. Drain Current

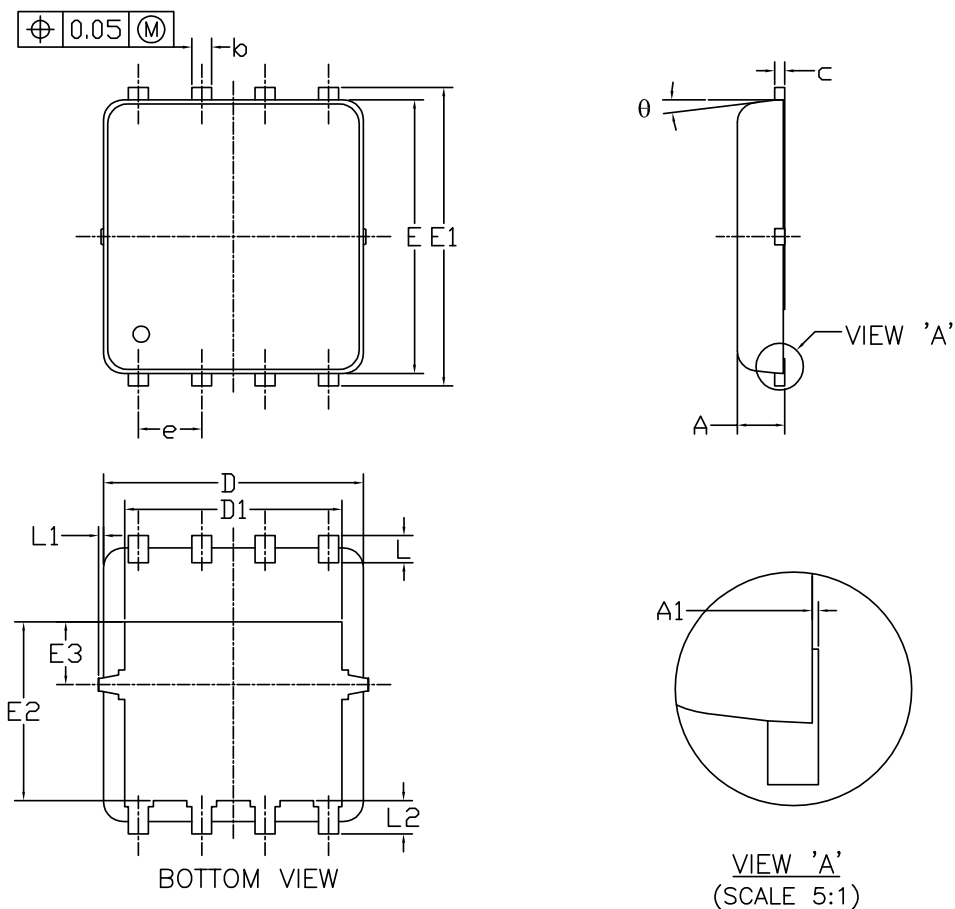


Safe Operating Area, Junction-to-Case

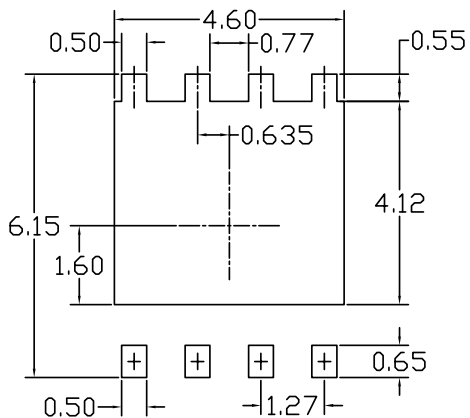


Normalized Thermal Transient Impedance, Junction-to-Case
