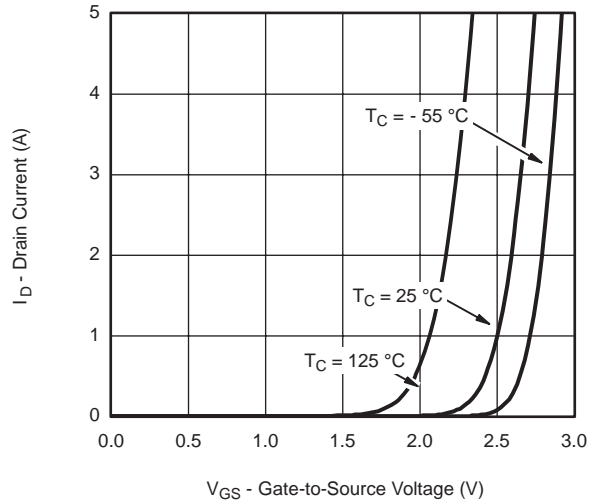

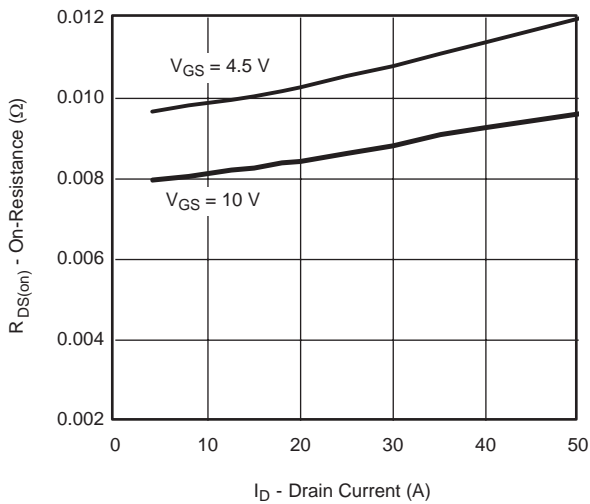
$V_{GS}$  - Drain-to-Source Voltage (V)

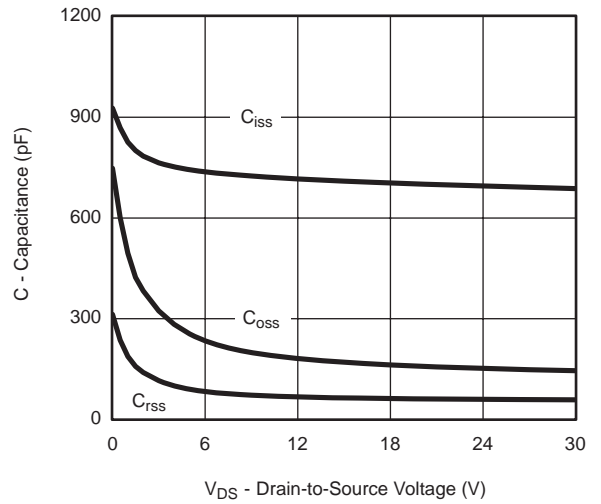


$V_{GS}$  - Gate-to-Source Voltage (V)

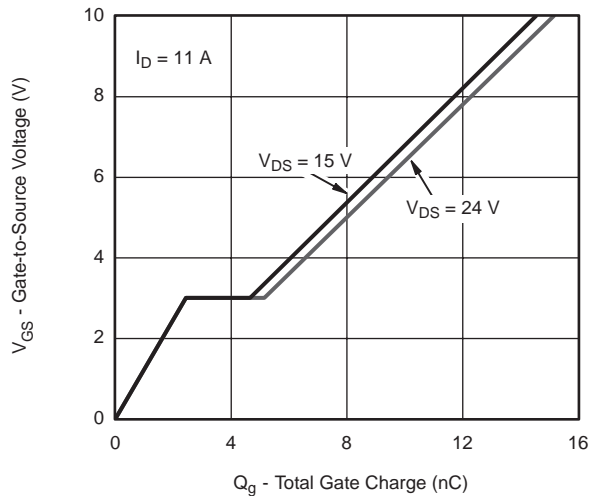

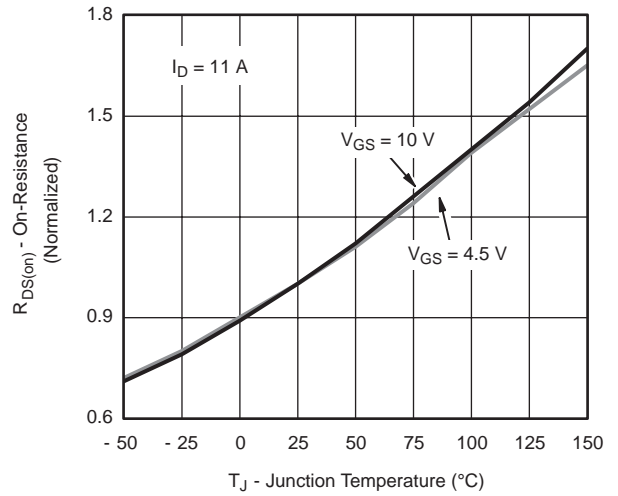
**On-Resistance vs. Drain Current and Gate Voltage**

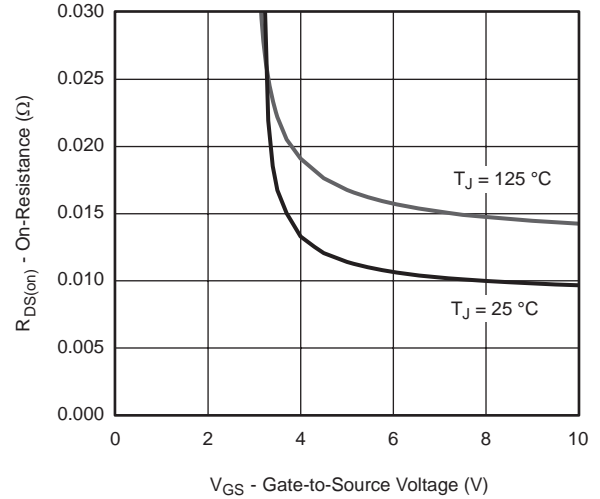


**On-Resistance vs. Junction Temperature**

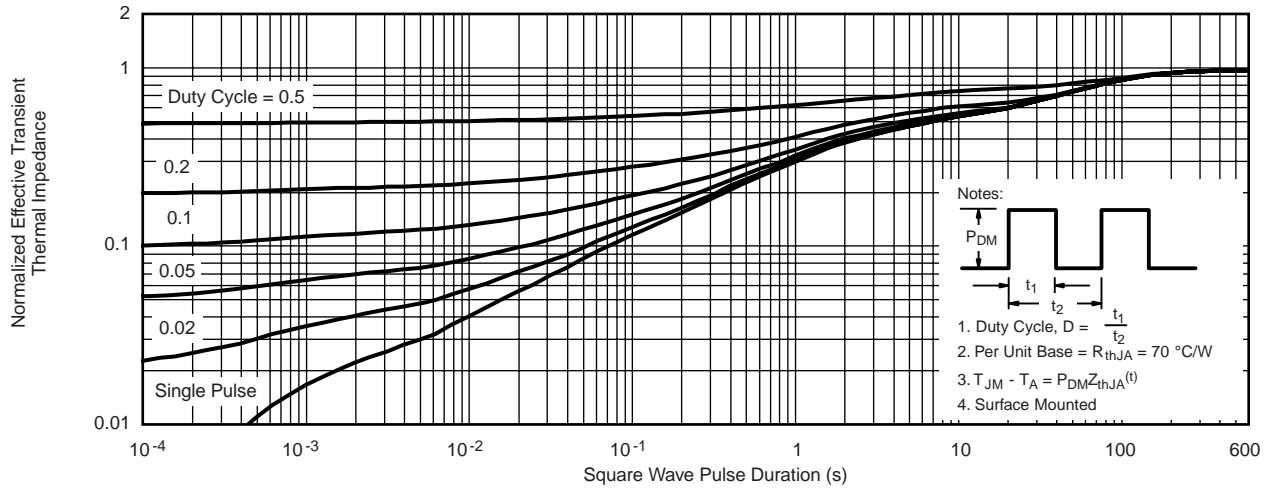
